That the Mayor and City Clerk be authorized to execute the new January 1, 2024 to December 31, 2028 collective agreement between The Corporation of the City of Barrie and the Barrie Professional Fire Fighters Association (BPFFA), based upon the tentative settlement reached on July 11, 2025, which is within the parameters established by City Council.
2. That the Director of Human Resources, or their designate, be authorized to execute Letters of Understanding (LOUs) and/or Letters of Intent (LOIs) between The Corporation of the City of Barrie and the BPFFA to address matters such as legislative changes, clarification of the intent of the agreement language, changes resulting from the resolution of a grievance or a complaint, trial periods for pilots of new initiatives or to formalize plans with the Association. (FES001-25)

This matter was recommended (Section "B") to City Council for consideration of adoption at its meeting to be held on 7/23/2025.
