BY-LAW NUMBER 2017-

A By-law of The Corporation of the City of Barrie to permanently close the soil and freehold described as Part of Park Lot 10, Registered Plan 190, designated as Part 1 on Plan 51R-40947, (known as Edgehill Drive), and being Part of PIN: 58768-0492 (LT), City of Barrie.

WHEREAS Section 8 of the *Municipal Act, 2001*, S.O. 2001, c. 25 (the "Act"), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

AND WHEREAS pursuant to Section 34 of the Act, the Council of every Municipality may pass by-laws to permanently close a highway;

AND WHEREAS the land described as that Part of Park Lot 10, Registered Plan 190, designated as Part 1 on Plan 51R-40947, (known as Edgehill Drive), and being Part of PIN: 58768-0492 (LT), City of Barrie is no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the City of Barrie hereby enacts the following:

1. **THAT** that Part of Park Lot 10, Registered Plan 190, designated as Part 1 on Plan 51R-40947, (known as Edgehill Drive), City of Barrie, being Part of PIN: 58768-0492 (LT), be and is hereby permanently closed.
2. **THAT** the City Clerk be authorized to execute all documents necessary to carry out the intent of this by-law.
3. **THAT** this By-law will have effect upon registration in the Land Registry Office of Simcoe County.
4. **THAT** Schedule "A" to this By-law, being an Affidavit of Melissa McCabe, sworn June 20, 2017 forms a part of this by-law.

READ a first and second time this 26th day of June, 2017.

READ a third time and finally passed this 26th day of June, 2017.
