Recommendation(s):

That By-law 2012-200 concerning the establishing and regulating of Barrie Fire and Emergency Services be repealed and replaced with the draft by-law attached as Appendix A to Staff Report BFES003-25.

Executive Summary:

The purpose of this report is to recommend repealing and replacing By-law 2021-200 regarding Establishing and Regulating ("E&R") of the Barrie Fire and Emergency Service as a number of updates are required and to meet current legal compliance requirements and standards.

Key Findings:

A review of the current E&R By-law revealed that it requires a number of updates and expanded detail in several key areas. Specifically, to address changins to definitions, role descriptions, and responsibility descriptions. Updates to the By-law are also required in order to be to be compliant with the Fire Protection and Prevention Act (FPPA), Emergency Management and Civil Protection Act (EMCPA), the Ministry of Emergency Preparedness and Response (EMO), and Ontario Fire Marshal (OFM) Standards, and best practices. The changes to the By-law are included in Appendix A, and a summary of improvements is included in Appendix B to this Staff Report.

The 2025 E&R by-law represents a substantial modernization of the department's legal and operational framework. It enhances transparency, compliance, risk governance, interagency coordination, and Council oversight. These changes are essential to reflect Barrie's growth, updated legislation, modern fire service standards, and the strategic vision articulated in the Fire Master Plan.

Financial Implications:

There are no financial implications for The Corporation resulting from the proposed recommendation.

Alternatives:

The following alternatives are available for consideration by General Committee:

Alternative #1 — General Committee could maintain the existing E&R By-law. This alternative is not recommended as the current version is not compliant with multiple sections of the Fire Protection and Prevention Act (FPPA), Emergency Management and Civil Protection Act (EMCPA), the Ministry of Emergency Preparedness and Response (EMO), and Ontario Fire Marshal (OFM) Standards, and best practices.

Although this alternative is available, staff do not recommend it as it leaves the City of Barrie in a position of legal vulnerability and increases overall risk.
