2024 INVESTMENT MANAGEMENT

Thierry Rayaisse, Portfolio Manager, and Jason Bayley, Investment Analyst, reviewed the management of the City's 2024 investments concerning the portfolio performance, performance drivers and the market outlook.

- The increased duration ahead of interest rate cuts;

- The rebalancing to positively impacted returns; and
- An outlook of the current market.
