#### RECOMMENDED MOTION

That the General Manager of Infrastructure & Growth Management be authorized to execute a Letter of Intent with the County of Simcoe with respect to negotiating a joint venture agreement for the development and use of a shared facility for a First Responders Campus in the form approved by the Director of Facilities & Transit and the Director of Legal Services.

#### **PURPOSE & BACKGROUND**

#### Report Overview

2. This Staff Report is intended to provide an update to Council on the First Responders Campus Development Plan project.

#### Background

- 3. On June 17, 2013 Council adopted motion 13-A-080 authorizing staff to proceed in developing the First Responders Campus Development Plan, and subsequently adopted motion 14-G-190 on August 25, 2014, authorizing staff to proceed with conditional offers to purchase on identified potential properties.
- 4. On June 1, 2015, a Confidential Memorandum entitled "City of Barrie First Responders Campus --Project Update" provided an update to General Committee on the First Responders Campus Development Plan and Comparative Study to assist in providing a recommendation for selection of the preferred site.
- 5. The Confidential Memorandum laid out a series of Next Steps. The following table provides an update on the actions staff have taken to complete the Next Steps.
