



**BY-LAW NUMBER 2014-**

**A By-law of The Corporation of the City of Barrie to accept the “as-constructed” municipal services within and complementary to the Dunsmore Subdivision (Phase 1A) and to assume the street for public use.**

**WHEREAS** Section 10 of the Municipal Act, 2001, S.O. 2001, c.25 as amended (the “Municipal Act, 2001”), provides that a single-tier municipality may pass by-laws respecting matters set out therein including, inter alia public assets of the municipality acquired for the purpose of exercising its authority under the Municipal Act, 2001 or any other Act;

**AND WHEREAS** The Council of The Corporation of the City of Barrie passed Motion 11-G-276 delegating authority to the Director of Engineering to accept the municipal infrastructure within Plans of Subdivision;

**AND WHEREAS** The Council of The Corporation of the City of Barrie deems it expedient to assume Quarry Ridge Road identified on Plan 51M-689 as shown in the attached Schedule “A”, in the City of Barrie, County of Simcoe;

**NOW THEREFORE**, the Council of The Corporation of the City of Barrie enacts as follows:

1. **THAT** Quarry Ridge Road identified on Plan 51M-689 as shown in the attached Schedule “A”, in the City of Barrie, County of Simcoe be assumed for public use.
2. **THAT** the “as-constructed” municipal services within and complementary to the Dunsmore Subdivision (Phase 1A) be accepted.
3. **THAT** this By-law shall come into force and have effect immediately upon the final passing thereof.

**READ** a first and second time this 13<sup>th</sup> day of January, 2014.

**READ** a third time and finally passed this 13<sup>th</sup> day of January, 2014.

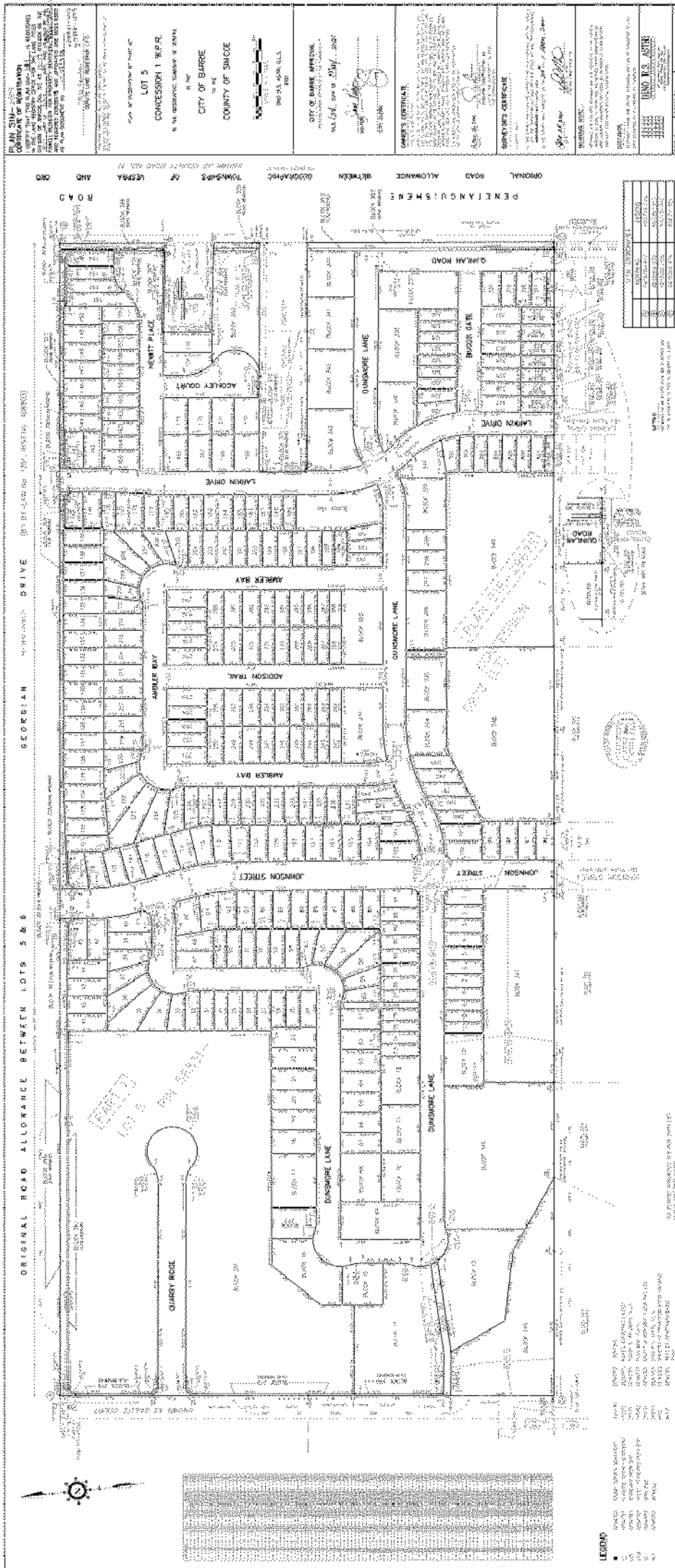
