Allison Craig from BioForest provided a presentation concerning the LDD Moth (formerly known as Gypsy Moth) Management Options.

Ms. Craig discussed slides concerning the following topics:

- An overview of the organization and the options related to LDD Moths;
- The organization's management options;
- The following types of options for controlling LDD Moths:
 - Mechanical Control - Egg Mass Scraping;
 - Mechanical Control - Burlap Banding;
 - Mechanical Control - Bug Barrier;
 - Chemical Control - Individual Trees;
 - Chemical The and Forested Areas, and
 - No control.
- Photographs illustrating the impact on trees not controlled for gypsy moths; and
- The organization's annual monitoring options for LDD Moths.

Members of Committee asked a number questions of Ms. Craig and received responses.

PRESENTATION CONCERNING THE WASTEWATER ASSET MANAGEMENT PLAN

Kelly Oakley, Manager of Corporate Asset Management and Scott Drewette, Senior Asset Management Coordinator provided a presentation concerning the Wastewater Asset Management Plan.

- The next steps in corporate asset management.
