The General Committee met and reports as follows:

10-G-420 COUNCIL ORIENTATION PRESENTATION CONCERNING THE CITY OF BARRIE'S FINANCIAL CONDITION AND 2011 BUSINESS PLANNING PROCESS

J. Babulic, Chief Administrative Officer provided an overview of the purpose of the Orientation Session concerning the City of Barrie's financial condition and 2011 business planning process. He noted that there is a need to link the Business Plan to Council's strategic priorities and to relate the City's financial situation to the services it provides as well as the level of service provided. J. Babulic shared high level information concerning initial performance data comparisons with other participating Ontario Benchmarking Initiative (OMBI) municipalities, commenting that the benchmarking data can be utilized to inform judgements about performance however, it will require further analysis and should not be judged out of context.

E. Archer, General Manager of Corporate Services explained the Public Sector Accounting Board's definition of financial condition. He outlined the City's current situation as it relates to its financial sustainability, flexibility and vulnerability, providing trend information and factors influencing each of them. E. Archer noted that key issues related to the City's financial condition include:

- There are insufficient reserve balances to fund current and long term capital requirements;
- Debt capacity is anticipated to be fully utilized within the next ten years;
- Asset management and development requirements influence the composition and timing of the capital budget; and
- An improved understanding of service levels and cost drivers is required.

E. Archer discussed the status of the City's asset management portfolio and the process for evaluating assets to determine their importance to the delivery of service. He provided an overview of the City of Barrie's business planning framework. E. Archer outlined the objectives for the development of the 2011 Business Plan. He explained the factors impacting the Tax-supported Operating Budget as well as information concerning the 2011 Draft Capital Budget. E. Archer described cost drivers related to the User-rate supported (water, wastewater and parking) Operating Budgets and provided initial details concerning service partner budget requests for 2011. He projected that a 5.6% property tax-increase would be required to fund the proposed 2011 programs and services, including recommended program changes. E. Archer supplied information concerning options to reduce the potential property tax increase including service level changes and a longer term tax levy plan. He concluded by presenting the proposed next steps and timing related to the 2011 Business Plan and Budget.

Members of the Committee asked questions concerning:

- The factors influencing municipal taxes;
- Barrie's tax rates as a percentage of household income;
- The process to identify projects to be included in the 2011 capital plan;
- The savings associated with the provincial uploading of Ontario Disability Support Program and Ontario Works costs;
- The length of debenture associated with the Surface Water Treatment Plant and Water Pollution Control Centre expansion as well as the percentage of existing debt associated with the two projects;
- The level of debt capacity and trends related to debt capacity per household;
- The status of specific projects in the draft capital plan;
- The use of dividends from the PowerStream merger;
- Ontario Municipal Benchmarking Initiative (OMBI) data availability;
- The status of the commitments to the Royal Victoria Hospital and Georgian College expansion projects;
- A potential four year tax levy plan and a capital tax levy;
- The difference between the inflation rates for the types of products and services purchased by homeowners as compared to municipalities;
- Barrie's current competitiveness with other municipalities as it relates to tax levels;
- The amount and source of unfunded liabilities;
- The five items of highest risk related to asset management and the process to determine the ranking of capital projects;
- The factors influencing the sustainability of the City's financial condition;
- The impact of accelerating growth on the City's financial condition; and
- The percentage of the budget associated with service partner requests. (File: F00)

The General Committee met and reports as follows:

10-G-421 DEVELOPMENT OF STRATEGIC PRIORITIES FOR THE 2010 TO 2014 CITY COUNCIL TERM OF OFFICE.

Mayor J. Lehman provided opening remarks related to the first strategic planning session for the 2010 to 2014 City Council term of office. He spoke about the importance of strategic planning and the establishment of strategic priorities for the term. Mayor J. Lehman outlined major initiative areas related to growth management, downtown revitalization and fiscal responsibilities, noting that an overview concerning each of these topics as well as a number of other projects and issues had been included in information provided to members of City Council as part of their orientation package. He commented on the past City Council's strategic priorities and his thoughts related to establishing strategic priorities for this term.

Mayor J. Lehman asked each of the members of City Council to describe an item about their vision for Barrie in twenty years. Visions for the future of Barrie as well as the completion of specific projects were identified by individual members.

- C. Kearns of The Randolph Group provided a presentation outlining the objectives for the session and provided an overview of the agenda. She requested that members of City Council provide feedback concerning their expectations related to the strategic planning session. Individual members provided comments concerning their expectations and asked questions related to the strategic planning process.
- J. Babulic, Chief Administrative Officer provided information concerning the linkages between a vision, clear goals and identifiable action items. He reviewed the continuous management cycle and highlighted the results of a citizen survey concerning City services. J. Babulic explained his perspective concerning the relationships between strategic planning, a community vision, Council's Strategic Plan, community services and service levels, projects related to community building, master plans, the business plan and budget, departmental work plans and the projects and processes within each department. He provided an overview of the National Quality Institute (NQI) Program and the status of the City's Journey of Excellence. Members of City Council asked a number of questions concerning the information provided and commented on the implementation of strategic priorities.
- C. Kearns described the aspects of a strong vision statement, reviewed the community vision statement approved in 2003 and asked members of City Council to provide words and phrases to depict their future vision of Barrie. Members of City Council supplied words and phrases to be utilized by staff to develop a draft community vision for City Council's consideration.

The Committee recessed at 11:54 a.m. and reconvened at 1:02 p.m.

- C. Kearns outlined the importance of goals to support the vision and describe the desired outcomes. Five potential goal areas related to promoting economic development, managing growth, creating a vibrant and healthy City Centre, strengthening fiscal responsibility and expanding community involvement and responsiveness to the communities needs and expectations were discussed. Members of City Council requested that the wording related to the goals be further enhanced by staff.
- C. Kearns explained the difference between goals and the strategies developed to support the goals. Members of City Council discussed three to five potential strategies related to each of the goal areas and staff were asked to utilize the input received to refine the strategies for review and approval by City Council.

Members of City Council were requested to and provided feedback concerning the session. Next steps in the development of the 2010 to 2014 City Council's strategic priorities were discussed. (File: C08)
