The Seniors and Accessibility Advisory Committee met and reports as follows:

### **COMMITTEE TRAINING**

Tracy Macdonald, Deputy City Clerk, provided a presentation to the committee regarding committee process

Ms. Macdonald discussed slides concerning the following topics:
