

# COMMITTEE OF ADJUSTMENT PROVISIONAL DECISION WITH REASONS SUBMISSION NO. A55/24

**IN THE MATTER OF** the Planning Act, R.S.O. 1990, c.P.13, as amended, and of Zoning By-law No. 2009-141, of the City of Barrie, Section 13.3.37.

**AND IN THE MATTER OF** the premises described as PT BLK 351 PLAN 51M689, PARTS 1 AND 3 TO 10 RP 51R40612 and known municipally as **1 Quarry Ridge** in the City of Barrie.

AND IN THE MATTER OF AN APPLICATION by Innovative Planning Solutions c/o Nick Skerratt on behalf of Centurion Appelt (Royal court Barrie) LP for relief from the provisions of Zoning By-law No. 2009-141, under Section 45 of the Planning Act, R.S.O. 1990, c. P.13, so as to permit a childcare area within an existing multi-tenanted building to exceed the maximum allowable gross floor area.

The applicant sought the following minor variance(s):

1. A gross floor area of 537.53 square metres, whereas the Comprehensive Zoning By-law 2009-141, under Section 13.3.37, permits a maximum gross floor area of 25% of the total gross floor area of a multi-tenanted building to a maximum of 300 square metres.

DECISION: That the variance(s) noted above be **GRANTED**.

Committee had regard for the written submissions received on this application when making their decision.

- 1. The intent and purpose of the Official Plan is maintained.
- 2. The intent and purpose of the Zoning By-law is maintained.
- 3. The variance(s) are desirable for the appropriate development of the lands.
- 4. The variance(s) is/are minor.

## **Appealing to The Ontario Land Tribunal**

The Planning Act, R.S.O. 1990, as amended, Section 45(12)

The applicant, the Minister or a specified person or public body that has an interest in the matter may within 20 days of the making of the decision appeal to the Tribunal against the decision of the committee by filing with the secretary-treasurer of the committee a notice of appeal setting out the objection to the decision and the reasons in support of the objection accompanied by payment to the secretary-treasurer of the fee charged by the Tribunal as payable on an appeal from a committee of adjustment to the Tribunal.

**Note**: In accordance with Section 45(12) of the *Planning Act* third party appeals by persons or individuals are not permitted. When no appeal is lodged within twenty days after the giving of notice, the decision becomes final and binding and notice to that effect will be issued by the Secretary-Treasurer.
