



BY-LAW NUMBER 2014-

A By-law of The Corporation of the City of Barrie to provide for advance voting and to provide for reduced hours of voting in institutions and retirement homes on Voting Day in the 2014 Municipal Election.

WHEREAS, Section 43(1) of the Municipal Elections Act, S.O., 1996 provides that a municipal council shall pass a by-law establishing one or more dates for an advance vote, and the hours during which voting places shall be open on that date or dates;

AND WHEREAS, Section 46(3) of the Act provides that a municipal council may pass a by-law with respect to reduced voting hours in voting places in retirement homes or those institutions as defined in Section 45(7) of the said Act, where the voting place is only for the use of the residents;

AND WHEREAS, the Council of The Corporation of the City of Barrie adopted motion 14-G-204 which provides for advance voting and reduced hours of voting in institutions and retirement homes on Voting Day in the 2014 Municipal Election;

NOW THEREFORE, the Council of The Corporation of the City of Barrie hereby enacts as follows:

1. **THAT** advance voting shall be held on the dates and hours specified in Schedule "A" attached hereto, with respect to the municipal election to be held on Monday, October 27th, 2014:
2. **THAT** reduced hours of voting in institutions and retirement homes shall be held on Voting Day, Monday, October 27th, 2014, as specified in Schedule "B".
3. **THAT** this by-law shall come into force and effect immediately upon the final passing thereof.

READ a first and second time this 25th day of August, 2014.

READ a third time and finally passed this 25th day of August, 2014.

ADVANCE VOTING

Any City of Barrie Elector
1 voting location on Saturday, October 11 th , 2014 between 9:00 a.m. – 2:00 p.m.
20 voting locations on Tuesday, October 21 st , 2014 between 2:00 p.m. and 8:00 p.m.
20 voting locations on Wednesday, October 22 nd , 2014 between 2:00 p.m. and 8:00 p.m.
20 voting locations on Thursday, October 23 rd , 2014 between 2:00 p.m. and 8:00 p.m.
20 voting locations on Friday, October 24 th , 2014 between 2:00 p.m. and 8:00 p.m.
20 voting locations on Saturday, October 25 th , 2014 between 10:00 a.m. and 6:00 p.m.

Residents of buildings/complexes containing 75 or more dwelling units
Wednesday, October 15 th , 2014 between 10:00 a.m. and 2:00 p.m. or 4:00 p.m. and 8:00 p.m.
OR
Thursday, October 16 th , 2014 between 10:00 a.m. and 2:00 p.m. or 4:00 p.m. and 8:00 p.m.
OR
Friday, October 17 th , 2014 between 10:00 a.m. and 2:00 p.m. or 4:00 p.m. and 8:00 p.m.

Retirement Homes/Institutions Residents of the specific institution or retirement home only
Wednesday, October 15 th , 2014 between 9:30 a.m. and 11:30 a.m. or until such time as an officer of the institution in conjunction with the election official, determine that the eligible electors residing at the subject facility have been provided an opportunity to vote
OR
Thursday, October 16 th , 2014 between 9:30 a.m. and 11:30 a.m. or until such time as an officer of the institution in conjunction with the election official, determine that the eligible electors residing at the subject facility have been provided an opportunity to vote
OR
Friday, October 17 th , 2014 between 9:30 a.m. to 11:30 a.m. or until such time as an officer of the institution in conjunction with the election official, determine that the eligible electors residing at the subject facility have been provided an opportunity to vote

SCHEDULE "B" TO BY-LAW NUMBER 2014-

**REDUCED HOURS OF VOTING FOR RETIREMENT HOMES AND INSTITUTIONS
ON VOTING DAY (MONDAY, OCTOBER 27, 2014)**

Retirement Homes/Institutions - residents of the specific institution or retirement home
Between 9:00 a.m. and 10:00 a.m. or until such time as an officer of the institution in conjunction with the election official, determine that the eligible electors residing at the subject facility have been provided an opportunity to vote
OR
Between 10:30 a.m. and 11:30 a.m. or until such time as an officer of the institution in conjunction with the election official, determine that the eligible electors residing at the subject facility have been provided an opportunity to vote
