**The Heritage Barrie Committee met and reports as follows:**

**SECTION "A"**

**2016 WORK PLAN**

The Committee met and discussed goals for the Heritage Barrie Committee for 2016. The Committee developed the following objectives to promote Barrie heritage:

- Promote Ontario Heritage Week;
- Coordinate the 2016 Heritage Barrie Awards program; and

**MUNICIPAL HERITAGE COMMITTEES ORIENTATION WORKSHOP REVIEW**

K. Brislin, Senior Policy Planner provided an overview of the Cultural Heritage Conservation Workshop which was hosted by the City of Barrie on November 25, 2015. Ms. Brislin received positive comments from participants regarding the workshop. **DEVELOPMENT APPLICATIONS UNDER REVIEW**

K. Brislin, Senior Policy Planner advised that a sign application for a property located adjacent to the South Shore Community Centre is being reviewed. Ms. Brislin noted that the South Shore Community Centre is a designated heritage property.

**CORRESPONDENCE FROM NATIONAL TRUST FOR CANADA REQUESTING A DONATION TO THE LAUNCH PAD INITIATIVE**

C. Tribble, Chair reviewed a request from National Trust for Canada seeking support from the Heritage Barrie Committee to assist with the cost of planning and executing the national Launch Pad initiative. Mr. Tribble explained that the Launch Pad initiative assists communities to save community assets of historical importance.

D. McAlpine, City Clerk/Director of Legislative and Court Services provided background information regarding the City of Barrie's 2016 Business Plan.

The Committee discussed the request to financially support the Launch Pad initiative and agreed not to support the initiative.
