RECOMMENDED MOTION

Operating Budget Approvals:

- 1. That the 2022 tax-supported base operating budget for municipal operations, with total gross expenditures of \$392.4 million and a net property tax levy requirement of \$268.1 million, be approved with the following amendments to reflect changes since the 2022 Business Plan's publication on November 8, 2021:
 - a) That \$65,000 be added to the 2022 budget for the completion of phase 1 of the Wayfinding Master Plan project with offsetting funding from the Tourism Reserve;
 - b) That \$15,000 be added to the 2022 budget for the Operations Department to cover costs of potential graffiti removal and winter maintenance for the Heart Barrie sign as per motion 21-G-166; and
 - c) That \$606,000 be added to the 2022 budget for increased insurance expense.
- 2. That the 2022 budget request from the Barrie Police Services Board presented on page 23 of the 2022 Business Plan, with a gross tax supported municipal funding requirement of \$58.9 million, be approved.
- 3. That the 2022 budget request from the Barrie Public Library Board presented on page 23 of the 2022 Business Plan, with a gross tax supported municipal funding requirement of \$9.2 million, be approved.
- 4. That the 2022 budget request from the County of Simcoe, including contributions to the County of Simcoe Capital Reserve, presented on page 23 of the 2022 Business Plan, with a gross tax supported municipal funding requirement of \$25.3 million, be approved, with the following amendments to reflect changes since the 2022 Business Plan's publication on November 8, 2021:

- a) That the budget for Long Term Care be decreased by \$303,700;
- b) That the budget for Children and Community Services be decreased by \$1,260;
- c) That the budget for Social Housing be decreased by \$23,782;
- d) That the budget draw from the County of Simcoe Capital Reserve to support provider loans be decreased by \$297,580;
- e) That the budget for Paramedic Services be increased by \$280,340;
- f) That the budget for Ontario Works be increased by \$100,140; and
- g) That the budget for Museum and Archives be increased by \$740.
- 5. That the 2022 tax supported base Operating Budget for the remainder of Barrie's Service Partners presented on page 23 of the 2022 Business Plan, with total gross expenditures of \$3.9 million, and a net property tax levy requirement of \$2.8 million, be approved, with the following amendments to reflect changes since the 2022 Business Plan's publication on November 8, 2021:

12. That \$529,000 of Safe Restart Funding be used to offset increased expenses and decreased revenue for the Barrie Police Service in 2021 related to the ongoing impacts of COVID-19.

Capital Budget Approvals:

- 13. That, consistent with the Capital Project Control Policy, the 2022, 2023, 2024, 2025, and 2026 Capital Budget relating to new capital spending requests of \$74.8 million, \$66.8 million, \$39.3 million, \$12.2 million, and \$8.0 million respectively be approved with the following amendments to reflect changes since the 2022 Business Plan's publication on November 8, 2021, and the 2022-2026 Capital Budget items not requiring spending approval, be received as forecast information:
 - a) That the following projects be deleted:
 - i) 000156 Allandale Recreation Centre Facility Renewal Assessment in the amount of \$2,900,000;
 - ii) 000179 East Bayfield Community Centre Facility Renewal Assessment in the amount of \$1,250,000;
 - iii) 00182 Holly Community Centre Facility Renewal Assessment in the amount of \$100,000;
 - iv) 000184 Lampman Lane Community Centre Facility Renewal Assessment in the amount of \$325,000:
 - v) 000160 Sadlon Arena Facility Renewal Assessment in the amount of \$3,250,000;

 - b) That the budget for project 000196 Parkview Community Centre Facility Renewal Assessment be reduced by \$125,000 in 2023 and \$8,000 in 2024;
 - c) That the County of Simcoe Capital Program projects be adjusted as follows:
 - FI1018 Long Term Care & Senior Services be increased by \$239,591.05 in 2022 with \$27,310.01 funding from DC Reserves and \$212,281.04 from the County of Simcoe Capital Reserve;
 - ii) FI1019 Paramedic Services be increased by \$435,946.42 in 2022 with \$182,313.43 funding from DC Reserves and \$253,632.99 from the County of Simcoe Capital Reserve;

- 14. That any Industrial Development Charge Discounts in 2022 be funded first from the \$200 thousand allocated annually in the operating budget, followed by any year-end surplus, with any remaining balance funded from the appropriate capital reserve.

By-law Update and Forecasts Received for Information:

- 15. That effective May 1, 2022, By-law 2021-020, as amended, be repealed, and replaced with a by-law incorporating the fees and charges presented in the 2022 Business Plan.
- 16. That forecast information for 2023, 2024, and 2025 presented in the 2022 Business Plan be received for information.

Council and Staff Authorization Requests:

- 17. That the Executive Management Team (EMT) be authorized to add temporary non-complement positions to the end of the budget year utilizing existing approved funds to deal with any unforeseen circumstances that impact delivery of City services.
- 18. That the Executive Management Team (EMT) be authorized to implement the economic adjustment for the Non-Union Group (NUG) of employees (including full time, part time and students), effective January 1, 2022.
- 19. That staff be authorized to submit applications for grants that would reduce expenditures associated with projects, programs and services approved as part of the Operating and Capital Budget.
- 20. That two of the following officers; either the Mayor, Clerk, Treasurer or their designates, be authorized to execute any agreements that may be required to accept grant funding from other levels of government or other partners, to reduce expenditures associated with programs, services, and/or capital projects.
- 21. That staff be authorized to submit applications for grants that would reduce future capital expenditures, fund service enhancements or enable capital projects to be advanced, and a report or memo be presented, as appropriate, prior to the execution of any agreement associated with the acceptance of such grant.
- 22. That the Treasurer be authorized to make the necessary alterations to the transfer to and/or from reserves to reflect changes since the 2022 Business Plan's publication on November 8, 2021.
- 23. That the City Clerk be authorized to prepare all necessary by-laws to implement the above recommendations.

PURPOSE & BACKGROUND

Report Overview

- 24. The purpose of this Report is to recommend the Corporation's 2022 Business Plan. The direction provided by Council in motion 21-G-163 (provided in Appendix "A") established a target for the 2022 budget to not exceed the aggregate of the following three components:
 - a) 2.00% for operations excluding legislated changes, growth related requirements, and previous Council motions (0.35%); and
 - b) An increase of 0.75% for the Dedicated Infrastructure Renewal Fund.

This amounts to a 3.10% maximum tax rate increase based on Council's 2022 budget directions. Before taking amendments into account, the recommended operating budget proposes a 3.30% tax rate increase.

25. The listing of Debenture Financing in Appendix "B" is intended to enhance transparency of approvals and make the debenture issuance process more efficient. The list contains debenture amounts for new budget requests and previously approved issuance amounts that are outstanding. Forecasted debenture amounts are excluded from the listing.

Background

- 26. On November 8, 2021, copies of the 2022 Business Plan/Capital Plan binders were distributed to members of Council. The same information was posted on the City's website (https://www.barrie.ca/City%20Hall/Budget/Pages/Budget.aspx) on November 9, 2021. A presentation was also made at the General Committee meeting held on November 8, 2021 to provide an overview of the details contained within the 2022 Business Plan/Capital Plan binders.
- 27. As the details related to the City's annual budget and business plan/capital plans are quite extensive, it would be challenging to address all of the aspects in a staff report. The budget binders are intended to provide the necessary level of detail to allow members of Council to make informed decisions on its business planning for the year, as well as capital project plans. Given the scope of the City's business activities, budget binders were distributed in early-November to allow for a fulsome review of the details.
- 28. The Executive Summary, Operating Budget and Financial Overview, and Capital Plan Overview provide details related to the services provided, proposed expenditures, and revenue sources. They also highlight significant drivers related to changes in the cost to maintain existing service levels, new investment and service recommendations, service partner requests, the City's financial condition, and Capital Program.
- 29. The focus of this staff report is to advise General Committee of any changes since the publication of the 2022 Business Plan/Capital Plan binders on November 8, 2021.

ANALYSIS

OPERATING BUDGET

Amendments increase the original 3.30% tax levy to 3.67%, no change to user rates

- 30. The tax-based budget as presented in the 2022 Business Plan binder includes a 2.55% tax rate increase for the projected cost to maintain existing service levels for all municipal services, service partner funding requests, and new investments in services for 2022. In addition, the tax-based budget includes a 0.75% tax rate increase for the Dedicated Infrastructure Renewal Funding bringing the total increase to 3.30%.
- 31. The adjustments included as part of the recommended motion to address changes since the publication of the binders, if approved, would result in a net \$1.1 million increase to the projected cost of 2022 programs and all recommended service level changes, while the 0.75% Dedicated Infrastructure Renewal Funding remains unchanged. This would result in the total blended tax rate increasing to 3.67%. After amendments, the estimated property tax bill for a typical home assessed at \$362,740 is expected to be approximately \$4,644 (2021 = \$4,480).
- 32. The proposed water and wastewater rate-based budgets as presented in the 2022 Business Plan binder include a recommended annual rate increase of 2.40% and 3.03% respectively. For a typical household that consumes 180 cubic metres of water annually, the annualized increase in cost is \$8.75 for water, and \$15.61 for wastewater.
- 33. The 2022 Business Plan reported a net tax levy requirement of \$265.9 million in 2022 for ongoing service delivery, excluding the Dedicated Infrastructure Renewal Funding. The net tax levy requirement, after adjusting for recommended amendments, is \$267.0 million reflecting a \$12.7 million increase over 2021 (2021 = \$254.3 million). The levy requirement incorporates the budgetary requirements of the City, the City's Service Partners, and the New Investment and Service Recommendations.
- 34. The 0.75% Dedicated Infrastructure Renewal Funding adds an additional \$2.2 million, bringing the total recommended 2022 Tax Levy to \$269.1 million.
- 35. Phase 1 of the Wayfinding Master Plan project was approved in the 2021 Business Plan with a budget of \$75,000 and equivalent funding from the Tourism Reserve. However, due to a longer recruitment time frame for hiring the Tourism Coordinator, the Request for Proposal document and plan was delayed until the fall of this year. It is expected that \$10,000 of the \$75,000 budget will be spent in 2021. As such the remaining \$65,000 is requested to be included in the 2022 budget to enable completion of the first phase of the project. Phase 2 funds have been included in the 2022 capital plan.
- 36. As part of the Heart Barrie landmark sign motion 21-G-166 approved an additional \$15,000 be added to the Operations Department 2022 budget to cover costs of potential graffiti removal and winter maintenance on and around the sign.
- 37. After the preparation of the 2022 Business Plan and Budget financial materials staff received information from the City's insurance broker about substantially increasing insurance rates. Staff have looked at a number of alternatives such as adjustments to deductibles, coverage, and providers. The most cost-effective solution while still maintaining appropriate coverages requires an increase of \$606,000 to the 2022 insurance budget to accommodate the increased rates that are affecting municipalities across the province.

- 38. **County of Simcoe** The preliminary budget for the County of Simcoe included in the City's 2022 budget was based on the County's long term financial plan. Staff received updated 2022 budget information from the County after the preparation of the 2022 Business Plan and Budget financial materials. The updated budget will require an increase to the net levy requirement of \$350,058 consisting of a \$52,478 increase in service costs and a decrease in the draw from the County of Simcoe Capital Reserve of \$297,580 due to a change in the allocation attributable to provider loans for social housing.
- 39. **Lake Simcoe Regional Airport –** The preliminary budget for the airport was an estimate based on historical spending. Staff received the updated 2022 budget request after the preparation of the 2022 Business Plan and Budget financial materials. The updated budget will require an increase to the net levy requirement of \$46,780.
- 40. **Simcoe Muskoka District Health Unit (SMDHU)** Due to the timelines of the budget development for SMDHU there were no preliminary estimates received and a placeholder increase of 2.0% was used in developing the 2022 Business Plan. On Wednesday November 17th, the Board of Health directed SMDHU management to draft a 2022 cost-shared budget with a levy of the obligated municipalities increasing by 4.9% over the 2021 municipal levy rates. This budget direction will require an increase to the net levy requirement of \$55,524.

Water and Wastewater Rates are in line with 2021 Financial Plan Update

- 41. The Water and Wastewater budgets were developed in line with the Water and Wastewater System Financial Plan 2021 update (21-G-140), and in accordance with directions provided by Council in Motion 21-G-163 (provided in Appendix "A"). The 2021 Financial Plan update estimated the need for increases of 3% for water and 5% for Wastewater in 2022. The 2022 Business Plan and Budget is in alignment with those rates, however, the timing of the rate increases is planned for May 1st, 2022 which results in annualized rate increases of 2.40% for water and 3.03% for wastewater.
- 42. For a typical home that consumes 180 cubic metres annually, the annualized cost of water and wastewater services in 2022 are estimated to be \$374 and \$531 respectively for a combined cost of \$905 (\$880 in 2021). This represents a 2.77% combined increase over 2021 levels of which \$8.75 relates to water, and \$15.61 relates to wastewater.
- 43. The contributions to Water and Wastewater Reserves reflected in the 2021 requested budget are \$7.2 million, and \$17.3 million, respectively.

Parking Rate revenues have continued to fall below expenditures

- 44. The 2022 Parking Operating Budget reflects the costs associated with the operations and maintenance of parking lots, parking structure and assets. The parking service is intended to be self-sustaining through user pay revenue. However, the previous operating model for the service has proven unable to generate sufficient revenue to meet the cost of annual operations on an ongoing basis.
- 45. An updated parking strategy was approved by Council in the fall of 2020 (20-G-168) and included rate increases that came into effect throughout 2021 as well as laying the foundation for a financially sustainable approach to parking going forward. However, the impact of the pandemic on parking revenues has put sustained pressure on the parking rate and shortfalls are expected to continue for 2022.
- 46. Parking Operations continues to generate an operating deficit requiring a draw from the Parking Reserve to balance the parking budget. For 2022, the draw from the reserve is expected to be \$1.4 million.

Safe Restart Funding for Barrie Police

47. The Barrie Police have identified additional expenses and reduced revenue in 2021 as a result of the ongoing pandemic. They forecast a total impact of \$529 thousand by year end. Safe Restart Funding is recommended to be allocated to the Barrie Police Service to cover these costs. City staff will include recommendations for the allocation of Safe Restart funding related to the City's 2021 operations in the 2021 Year End Staff Report. \$1.3 million of Safe Restart Funding is included in the 2022 budget as presented in the 2022 Business Plan.

Ontario Regulation 284/09 - Expenses not included in the 2021 Business Plan

- 48. Previous reports to Council described reporting requirements for tangible capital asset accounting that came into effect for municipalities in 2010. Generally, the effect of these requirements is to increase the level and type of information presented in the City's financial statements about the stock, condition, and use of tangible capital assets to support municipal operations, and to disclose information using the "full accrual" method of accounting. This method recognizes expenses when they are incurred and revenues when they are earned, regardless of when the cash outlay occurs.
- 49. Prior to passing the 2022 budget, municipalities are required to disclose amounts that are expensed in their financial statements, but not included in budgeted figures. For the City of Barrie this includes three expenses:
 - Amortization expense \$60.5 million;
 - Post-employment benefit expenses \$1.5 million; and
 - Solid waste landfill closure and post-closure expenses \$100 thousand.

CAPITAL BUDGET

5-Year plan from 2022 - 2026 forecasts \$1.167B in spending for growth and asset renewal

- 50. The 2022 Capital Budget is \$342.4 million, including \$141.0 million in previously approved funding, \$201.1 million in new funding requests, and \$332 thousand associated with New Investment and Service Recommendation Operating Budget requests. Details of the 2022 Capital Budget are found in the 2022 Capital Plan binder.
- 51. Consistent with the Capital Project Financial Control Policy, where the 2022 Capital Budget includes projects that will be completed over more than one reporting period, Council's approval of new projects in the 2022 Capital Budget would include approval of the funds required in 2022, 2023, 2024, 2025, and 2026 to conduct the work, totaling \$201.1 million.
- 52. In addition to the portion of the 2022 Capital Budget that is recommended for approval, the 2022-2026 Capital Plan provides a forecast for capital spending over the next five years. The 2022-2026 Capital Plan includes \$1.167 billion in spending and was developed with a focus on addressing the City's most critical asset renewal needs, areas currently experiencing service level deficiencies, and required investment to support the growth management process. It should be noted that despite the significant investment being made, many important projects were deferred. As aging assets fail, their ability to deliver service to the community will be impacted.

A number of Facility Renewal projects are no longer required

- 53. In preparing the 2022 Capital Plan, Facilities staff further defined the scope and details of a number of Facility Renewal Assessment projects. These were submitted as new projects in the 2022 Capital Plan and as a result, previously submitted projects related to the same work are no longer required. Projects 000156, 000179, 000182, 000184, 000160, and 000200 for the Allandale Recreation Centre, East Bayfield Community Centre, Holly Community Centre, Lampman Lane Community Centre, Sadlon Arena, and Southshore Community Centre can be removed in their entirety, and project 000196 for the Parkview Community Centre can be reduced by the amount indicated in the motion.
- 54. The capital budget for the County of Simcoe included in the City's 2022 budget document was based on preliminary estimates as material had not yet been received from the County. Staff received updated 2022 budget information from the County after the preparation of the 2022 Business Plan and Budget financial materials. The updated budget from the County will require an increase to the County of Simcoe Capital Program projects in the City's capital plan for Long Term Care, Paramedics, and Social Housing, as well as a new project for the Lake Simcoe Regional Airport.
- 55. The City commissioned a consulting report that presented various options to address a health and safety concern. Wastewater Operations staff feel they can implement one of the options internally, putting measures in place to ensure the safety of staff. This will eliminate the need for project EN1237 WwTF Sludge Thickening System Process Polymer System Replacement. Budget that was approved in previous years will be returned on the spring Capital Status Report and the project will be cancelled.
- 56. The Enbridge Gas main located at the Anne Street Railway crossing needs to be relocated due to inadequate offsets from the rail infrastructure in addition to asset renewal to address pipe corrosion. The cost sharing for this work is subject to the City's Franchise Agreement with Enbridge per Council motion 13-G-308. This request is to defray the costs that the City is responsible for.

Funding of Industrial DC Discounts are a fraction of the annual costs, which are around \$2M

- 57. The City's 2019 DC-Bylaw 2019-055 includes providing Industrial Development Charge Discounts. As is required under the Development Charge Act, these Industrial Development Charge Discounts must be funded from alternative sources.
- 58. The 2022 Business Plan and Budget includes \$200 thousand in the base budget to fund such discounts. However, based on the last five years, the annual costs of such discounts have been \$2.0 million. At the time of drafting this report, for 2021 to date the City has to fund approximately \$2.0 million of such discounts.
- 59. The City's Financial Policy Framework recommends any year end surplus be allocated to the City's Capital Reserves to supported needed capital renewal works. Relying on funding of Industrial DC discounts through year end surpluses and Capital Reserves further reduces the City's ability to completed needed renewal works.

STAFF AUTHORITY REQUESTS

To be able to add positions due to Unforeseen Circumstances

- 60. To ensure delivery of City services and the 2022 Business Plan and Budget it is recommended that the Executive Management Team (EMT) have the authority to add temporary non complement positions to address unforeseen events, such as new service demands, project workload and staff absences.
- 61. As identified in the City's Human Resource Complement Management procedure, the following rules would apply to such temporary non complement positions:
 - a) Funds must be available in the budget year to fund the position;
 - b) Length of term will not extend beyond that budget year;
 - c) Salary gaping targets must still be met for that budget year;
 - Appropriate approvals by way of Human Resources forms must be completed;
 - e) Any exceptions to the above will be reviewed by the Chief Administrative Officer in consultation with all members of EMT;
 - f) Departments will be required to prepare a memo for Council to outline the details of the position should the need to extend beyond the budget year as directed by EMT; and
 - g) The funding for these positions will not form part of the base operating budget unless approved by Council in the form of a motion.

To implement economic adjustments for Non-Union Group (NUG) Employees

62. The City is party to various collective agreements negotiated with its unionized workforce. Agreements with both of the major unions, the Barrie Professional Fire Fighters Association (BPFFA) and the Canadian Union of Public Employees (CUPE), are in place for 2022. However, the CUPE agreement expires as of June 30th, 2022. Budgeted labour costs reflect obligations set out in the BPFFA and CUPE agreements, and an economic adjustment for Non-Union Group (NUG) labour costs up to June 30th, 2022.

OTHER ITEMS

Recommended motions do not include 4 intake forms which if approved would add 0.26% to tax levy

- 63. Through various motions in 2021 Council has requested certain items to be presented for information as part of this report. These items have not been included as part of the recommended motion and an amendment to the motion would be required in order for the items to proceed. The following intake forms for consideration can be found in Appendix "C":
 - Georgian College Theatre operating cost implications for reopening as an interim solution until a new theatre is constructed (motion 21-A-026), with a tax levy impact of \$203,329 or 0.07%;
 - b) LDD Moth prevention via aerial spraying or the use of pheromone traps (motion 21-G-185), with a tax levy impact of \$135,180 or 0.05%;
 - c) Additional Enforcement Resources for proactive enforcement of yard maintenance, parking and property standards (motion 21-G-238), with a tax levy impact of \$220,895 or 0.08%; and

- d) Additional Zoning and Enforcement Resources for proactive enforcement of second suites and detached accessory dwelling units (motion 21-P-023), with a tax levy impact of \$174,379 or 0.06%.
- 64. The total impact of including all the above forms as part of the 2022 Operating Budget would be \$733,873 or a 0.26% increase to the tax levy.

Budget Engagement Summary showed interest in maintaining spending in many areas

- 65. Access Barrie collaborated with Finance to educate and engage the public throughout the 2022 Budget process using the Budget Allocator tool. The engagement tool collects feedback from residents, but it is not a statistically valid survey. The goal was to improve understanding of how tax dollars are spent and basic municipal budgeting processes, demonstrate value for money and get input from the public on key service areas.
- 66. Building on previous year's successes, residents were encouraged to choose how to invest their tax dollars and leave comments about their choices using the tool. Launched on September 16, 2021 through the City's online engagement platform buildingbarrie.ca, the tool included a snapshot of 11 major service areas in the tax-based Operating Budget that impact the daily lives of Barrie residents and businesses.
- 67. The tool closed for official submission and comment at midnight on October 27, 2021, with a total of 1,999 submissions. A summary of results and comments is included as Appendix "D".
- 68. Overall trends in the data show the majority of respondents chose to:
 - a) Decrease spending on fire and emergency service
 - b) Decrease spending on libraries
 - c) Decrease spending on recreation and culture services
 - d) Maintain current spending on roads
 - e) Maintain current spending on transit
 - f) Maintain current spending on solid waste operations
 - g) Maintain current spending on parks and forestry operations
 - h) Maintain current spending on development services
 - i) Maintain current spending on information technology
 - j) Maintain current spending on economic and creative development
 - k) Increase spending on police
- 69. To note, there was no limit to the number of times an individual could submit a response, and while there are some submissions that have the same IP address, the City nor the vendor administering the tool can confirm with accuracy if these instances are from multiple, different people in the same area (i.e. submitted in a public-access building, like a school or library), or a single person.
- 70. In addition to the Budget Allocator, staff executed a marketing campaign with the objectives of creating awareness on how the City spends tax dollars, and encouraging residents to submit their feedback via the tool. The campaign tactics included, but were not limited to, a media release, radio ads, social media ads (Twitter, Facebook and Instagram), updates to Barrie.ca, an e-bulletin, and print ads in This Week in Barrie. As of October 28, 2021, City-originated social media posts and ads about the 2022 budget generated more than 116 thousand combined impressions.
- 71. As part of the educational campaign, staff also included the opportunity for Barrie homeowners to review a personalized 'taxpayer receipt' that provided an estimated breakdown of how their 2021 tax dollars were used to fund City and partner services

ENVIRONMENTAL AND CLIMATE CHANGE IMPACT MATTERS

72. There are no environmental or climate change impact matters directly related to the recommendation. The 2022 Business Plans and Budgets reflect various initiatives and capital projects that support a more sustainable community, features that mitigate climate change risks, and measures that promote adaptation to climate change.

ALTERNATIVES

Barrie

73. There are five alternatives available for consideration by General Committee:

Alternative #1

General Committee could reduce the tax levy increase from 3.67% to 3.10% by increasing the draw from the Reinvestment Reserve by \$1,651,880.

This alternative increases the reliance on reserves by funding a larger portion of City operations from the Reinvestment Reserve and will create a tax levy pressure in future years when this subsidy is reduced. Currently the Reinvestment Reserve is funding \$3.5 million of City Operations via the Growth Strategy introduced in the 2020 budget, as well as the Council motion to utilize the reserve to reduce the tax levy in 2021 and 2022.

Alternative #2

General Committee could reduce the tax levy increase from 3.67% to 3.10% by increasing the draw from the Reinvestment Reserve, deferring the increased contribution to the Fleet Reserve, and eliminating the tax levy supported portion of the Community Improvement Plan (CIP) Reserve contribution for one year:

This alternative increases the reliance on reserves by funding a larger portion of City operations from the Reinvestment Reserve and will create a tax levy pressure in future years when this subsidy is reduced. It also reduces funding available to replace the City's fleet that have reached or exceeded end of life and results in higher operating expenses to maintain these aging assets. Finally, it reduces the contribution to the CIP Reserve which will result in less funding available for CIP initiatives such as Redevelopment Grants, Preservation of Built Heritage Grants, and Affordable Housing Grants. The contribution to this reserve was \$600 thousand in 2021 and increasing to \$1.2 million in 2022. This would reduce the 2022 contribution to \$1 million. The deferral of Fleet and CIP Reserve contributions by one year would create an additional tax pressure in 2023.

Alternative #4

General Committee could reduce the tax levy from 3.67% to 3.35% by doing a combination of Alternative #3 and either Alternative #1 or #2.

Alternative #5

General Committee could recommend an enhancement to the service level related to enforcement of various property standards, yard maintenance and parking matters by adding 2 of the 4 Municipal Law Enforcement Officers associated with Intake Form 1666 in Appendix "C". This would reduce the tax rate impact of the form to a total of \$110,448 or 0.04%. Together with Intake Form #641 that has been included as part of the recommended motion, this would result in a total of 4 new Municipal Law Enforcement Officers in 2022.

A minimum of 4 additional Municipal Law Enforcement Officers will be required to move from a reactive response to proactive response. While this alternative may not achieve the most desired level of proactive response that a total of 6 Officers would, staff believe it could result in a shift to a small but significant allocation of resources for proactive enforcement while balance the City's financial constraints.

74. The financial impacts of the 2022 Business Plan are addressed in the analysis section of this report.

NEW SERVICE LEVELS AND INVESTMENTS REQUESTED FOR CONSIDERATION BY COUNCIL

644 - GEORGIAN COLLEGE THEATRE

Community and Corporate Services

CONTACT: Dan Bell – Manager of Business Services (EXT. 4352)

DESCRIPTION:

Access to arts and culture is important to maintaining a healthy and vibrant lifestyle. To address this and support the performing arts community until a new, larger theatre is constructed, the Georgian Theatre is recommended to be re-opened. Re-opening Georgian Theatre will require a net operating cost to the City of Barrie of approximately \$214,500 which reflects estimated operating costs of \$346,200 offset by facility revenues of \$131,700. Should this intake form be approved, it will result in a \$203,000 increase to the tax levy. 2022 operating costs include minor capital expenditures of \$80,000 related to safety and facility requirements for this facility that is not owned by the City. Ongoing repair and maintenance costs of \$40,000 per year are also part of the financial projections, as part of the potential user agreement with Georgian College. This would be required to maintain absolute minimum safety and equipment standards for user groups and audiences. It does not address the \$1.3M in facility capital needs that have been identified as required over the next 4 - 5 years for the theatre elements that are beyond their lifecycle.

CONFIDENCE:

We are confident that Georgian Theatre will serve as a short-term option for specific staged events.

BENEFITS:

This solution will address a need for cultural performance space identified by the performing arts community. It is a short-term solution as the City moves forward with the potential of a new performing arts centre.

654 – AERIAL SPRAY FOR LDD MOTH – CITY WOODLOTS IN 2022 and 2023

Infrastructure & Growth Management

CONTACT: Kevin Rankin – Manager of Parks & Forestry Operations (EXT. 4754)

DESCRIPTION:

Direction from Council to provide the estimated Operating cost to apply a biological pesticide (Btk) aerially over city owned woodlots and parkland trees for the control (population reduction) of the LDD Moth (Lymantria dispar dispar).

The large number of LDD Moth caterpillars eating the leaves of trees in Barrie has been evident in 2021 resulting in complaints from residents requesting an aerial spray in the city. Several large, city owned woodlots and parks have been heavily defoliated by caterpillars which have also migrated out into adjacent residential properties causing damage to private landscaping, difficulty for residents to enjoy their yards and severe skin irritations caused by the hairs of the caterpillar.

Based on 2021 surveys of where the caterpillar defoliation is greatest, staff have estimated that 396 hectares of city owned woodland have populations at the threshold of at least moderate defoliation, the majority of which are in year 2 or 3 of populations and will most likely persist into 2022 and 2023, though at reduced levels. Of these woodlands, 35.1 hectares are projected to have increasing populations of LDD caterpillars and experience severe defoliation in 2022. If Council were to direct a targeted aerial spray program, these specific 35 hectares of woodland would be recommended for treatment.

Estimated Cost for Aerial Spray Program contract costs (not including administration, education, permits, public consultation):

- Targeted Areas of high populations (35 ha) \$53,000
- All affected City Woodlands (396 ha) \$400,000
- All affected City Woodlands and surrounding street trees and private properties (2,095 ha) -\$1,100,000.

Should Council direct aerial application of Btk, an 18-month contract position would be recommended to complete the public consultation, ground management of non-spray areas, public education, volunteer organization, population surveys, and contract administration.

Staff completed a mapping of the areas (private lands) surrounding city woodlots with high LDD moth populations. Were Council to direct staff to aerial spray private lands as well as city parks and woodlots, the total area of recommended spraying would be 2,095 hectares. Typically, Council would have to issue an emergency order and/or pass a municipal by-law authorizing staff to spray private lands.

Staff are not recommending large, broadcast spraying over residential areas for several reasons. The estimated cost for spraying broader areas would be a lower cost per area, however would be approximately \$1.1 million in contracted services. While members of the public are unlikely to experience any health effects, the following measures may be considered by residents living in treatment areas: • Whenever possible, remain indoors for 30 minutes after spraying to allow for the droplets to deposit onto the tree leaves. • Bringing laundry, toys and pets indoors before spraying begins. • Practice good personal and food hygiene (e.g., hand washing after outdoor activities, especially after gardening; leaving outdoor shoes at the door; washing all fruits and vegetables before eating or cooking). • Covering lawn furniture, outdoor tables, pools, BBQs, play equipment and sandboxes and/or rinsing them off with water after spraying is

finished. • Minimize opening and closing windows and doors during the spraying. • Shutting off the heating/cooling vents or selecting the recirculate setting. • Contacting a family physician if anyone is concerned that a personal medical condition may be aggravated by the spraying.

CONFIDENCE:

Btk is a biological pesticide that specifically targets Lepidoptera caterpillars in the early instars (small) through ingestion (feeding of leaves coated in Btk). It is aerially applied in two sprays; one in late May, one in early June. Used at the the correct time and environmental conditions, Btk is a proven method for reducing LDD Moth populations within treed areas applied over multiple years.

Budget approval, procurement and Purchase Order issuance will need to be completed prior to the end of March 2022 as Btk orders must be received by the manufacturer by April 1st of each year and all other associated approvals, public notifications and planning completed by the beginning of May 2022. There is only one existing aerial spraying contractor in Ontario who applies Btk for LDD Moth, and are currently at capacity with spray requests. As such, there is no guarantee they could perform aerial spray within Barrie in 2022.

Municipal and Provincial bylaws will need to be adhered to and an extensive Transport Canada risk assessment and approval process must be presented and approved. These plans will include application and timing restrictions, aircraft type restrictions, pesticide product restrictions, personnel experience requirements, public consultation, and notification among other requirements.

Other required parameters for spraying would include: 90% of the caterpillars hatched, minimum of 40% of the oak leaves flushed out, and all required permits and public notification periods completed.

Btk aerial spraying is also not expected to have adverse effects on vulnerable populations including children with asthma, people with weakened immune systems, pregnant women or the elderly. However, infrequently there may be some residents who are more sensitive and may experience skin, eye or respiratory irritation. In addition to the Btk active ingredient, other ingredients called formulants have also been studied broadly and do not have any significant health risks. Formulants normally include water and other ingredients to make the product stick to leaves and needles of trees. While the aerial spray will not eradicate the gypsy moth populations currently present, it will reduce populations to more manageable levels to protect tree canopies.

Update:

The County of Simcoe (as well as several other municipalities) have officially reported that they will not be spraying any areas for LDD Moth in 2022.

2021 Egg Mass Surveys have discovered that approximately 90% of the woodlands where LDD Moth is present is in population decline. 35 hectares of woodland will experience severe defoliation in 2022 (Sunnidale Park north woodland, Barwick Park, Hogan's Woods, Bayshore Ridge East-Wilkin's Walk, and Vine Crescent Ravine).

BENEFITS:

LDD Moth is currently at very high populations in several areas within the city as well as across all of Simcoe County. 2021 was reported to be year 2 or 3 of the population cycle and staff anticipate that due to 2021 spring conditions that LDD moth will be high again in 2022 and will persist in areas into 2023. This is a species that in the caterpillar stage causes severe defoliation of red oak, birch and poplar, and also causes moderate defoliation of most species of trees and shrubs present in Barrie.

The hairs of the LDD Moth also cause skin irritations and rashes in approximately 70% of people and the excessively large numbers of caterpillars in some areas cause residents great cause for concern. Waste from the caterpillar feeding is also a cause for complaint from residents.

Staff and Ward Councilors have received many complaints from area residents requesting aerial spraying of Btk to reduce populations of the LDD Moth.

As noted previously in the Enforcement Services Review (2020) and most recently the report related to rental properties, the ability to proactively enforce various regulations including those related to property standards, yard maintenance and parking will assist in building strong, vibrant and safe neighbourhoods. In the previous Enforcement Services Review it was noted that calls for service have increased by 54% over a period where no additional resources had been approved to address these calls. This increase in volume does not allow staff time for proactive enforcement in most areas. The additional resources will allow for the implementation of proactive enforcement of rental properties and the start to building better neighbourhoods.

Comments provided below:

Council should listen to residents who said that the police budget should be reduced by 5%, don't do public engagement if you're just going to ignore it.

Please don't increase taxes so that all the single, childless people paying the taxes are screwed. We don't even get discounts at the community centers like families do. It's so unfair.

Civilian members work alongside sworn members to deliver services to our community.

I see little value for the \$ spent on policing in Barrie. Pretty much zero enforcement of traffic laws, and the inmates have taken over. People constantly entering intersections after light has turned red, especially at advanced left turn lights, and I have seen so-one get ticketed.

Consider hiring the OPP for policing. Also your additional information or scare mongering is wrong, it suggests that it would eliminate 28 officers AND 14 civilian staff, AND body worn cameras, AND other stuff. by my math it would eliminate at most 18 officers or some mix of less officers eliminated and some program or civilian changes. The amount of money spent on Barrie police is insane. It's a bloated, ineffective mess.

The police are not delivering enough value for the investment being put in by the taxpayers. Police services are subpar, and not for lack of funding. To continue to fund them at this level without an increase in the quality of service provided is a waste of taxpayer dollars.

Make it -10%.

2 deputy Chiefs and 4 inspectors for service this small is ridiculous! Sending police to noise complaints should be bylaw.

They are way over budget. We don't need a police force that obviously caters to a minority of anti vaxxors while ignoring real crime.

I would support a reduction in police services with the cost savings allocated to community groups or programs that support residents suffering from mental illness, homeless shelters, or other localities where there may be increased intersections with law enforcement. More funding should be allocated towards educational and support programs so that we have safer communities without the need for a huge police budget. I would like to express my disapproval that 1/3 of tax dollars go towards law enforcement as I believe that there are more effective ways than law enforcement to have a safe community. Frankly I would support a reduction of 5% over the course of several years to bring the policing budget down, as it is extremely high right now. It would also be interesting if funds were used to conducting studies on how other regions or municipalities ensure safe communities with a smaller policing budget to really get a good sense of the impact of reducing and increasing this budget.

Council must prioritize what is essential within the city. Police salary costs are strangling the city's finances with their grossly excessive salary costs. City staff should be asked to create a report for council to compare the policing share of the current city budget to that of 10, 20 and 30 years ago (violent crime rates have plummeted over the years). It would be evident that the current excessive police budget allocation is unwarranted and is weakening the city's ability to finance badly needed programs and services causing:

- 1) Diminished the quality of life of Barrie citizens by siphoning off funds for cultural and environmental programs.
- 2) Ironically hurt the public's safety by decreasing road maintenance/upgrades, sidewalk /trail upgrades and education programs.
- 3) Decreased the potential of this city by limiting new hires and city staffing levels in other departments. There are so many badly needed programs and services in the city that are chronically under-funded because of the excessive policing costs that are continually exerted on Barrie's annual budget.

It should be more than 5%. I would like to see a 10% reduction instead.

Most police calls are non-criminal so reroute those calls to others including mental health experts, paramedics etc.

Better allocation of funding without reducing staffing levels.

There are other things that actually SUPPORT residents - affordable housing, mental health care, etc. that should be prioritized and our dollars would be much better spent there. How might we find a way to reallocate this funding?

We should move towards addressing public safety by ensuring that people have access to safe housing, health care, and social supports, rather than putting more cops on the streets, or throwing more money into superficial changes that have been demonstrated to have NO IMPACT on the rates of police violence and abuse of power (body cameras, sensitization training, etc). Police don't keep communities safe--it's time to start investing in our communities themselves!

Reduce by at least 10%.

Would reduce by more than 5%.

A movement needs to be made, as quickly as possible, to shift certain services ex mental health crisis services, to other bodies rather than the police. Funds should be redirected as quickly as union contracts permit.

The police budget represents a significant portion of the municipal budget already. Fire & Emergency Service

Barrie Fire & Emergency Service provides fire suppression, technical rescues, public education programs, fire inspections, and fire communication services.

Trim the fat!!

This department can find way to save and trim their budgets. For example, let's not order new fire truck now, but 2 years from now when we have a better picture of the economy, freeze wage increases, and no new hires for 1 year.

Please review the cost and service pros and cons of the 24 hour shift.

Not as many fires these days. They are not required to attend medical calls as we already have well trained Paramedics.

We are in need for more firefighters/stations as Barrie is growing, and they sacrifice their life and they put their life in danger to save our lives.

More community outreach on fire protection and making sure folks are up to safety standards. Fires can be prevented with proper community education. (Ex. Neighbour uses charcoal bbq inside garage. When fire was called, they advised to move the bbq onto the driveway. But didn't say it should be away from the home.) bring someone fishing they eat for a day, teach them how to fish.. they will eat for a lifetime.

Decrease police emergency funding.

Decrease fire spending specifically and put it towards EMS. Fire does not need to be spending 2k to go to hard of breathing complaint calls only to provide support till EMS arrives. Fire is only able to get to calls quicker because they have a monopoly on stations. If funding goes to EMS to get more stations, or they share with fire, they can be at those calls faster and eliminate the need for fire at health calls. Nothing against fire, they have just done a great job at minimizing fires in society and yet we still provide huge amounts of money to then to keep them relevant.

Stop grocery runs with large fire trucks!

Expensive Service. How much extra does 24 hour shifts cost? How can staff perform adequately?

I would like the city to review the 24 hour shifts. Is this cost effective for taxpayer? Does it compromise or enhance services? Fire is the only first responder or health care service operating on this schedule. Overpaid and over staffed - bring in OPP.

Stop sending fire to every single call. These extra calls just tries to justify the expenditure.

Home fires on the decline for years. Firefighters most overpaid profession constantly on sunshine list yet get least value from.

Decrease spending for Fire Services. They do not need to be attending 911 Medical calls.

I would love to reduce this more then 5%.

Make a portion of Barrie Fire into paramedics and downgrade to volunteer fire for a percentage.

The emergency services have received many increases over the years, equipment and a new building with credit I may add which is more expensive. Take the time and pay off those debts.

Decrease benefits for fire fighters. My friend's husband just retired. ALL of his benefits are still covered for FREE upon retiring??? There should at least be a premium. Fire fighters attend fewer high-risk situations than in the 80s and 90s due to evolutions in engineering.

There has to be some common sense when deciding which service respond to urgency. The Police Service must remain focused on crime, life threatening events.

As Barrie grows, there is a need for emergency services to keep pace. My husband had a heart attack at home and if firefighters had been 10 minutes rather than five, he might not have survived.

Increase here - we are seeing more and more need for emergency services and they are paid less than the police but do more. It's time to make the change and support them more.

Since our medical system doesn't work for many people, paramedics are needed to do what our doctors used to do.

Barrie needs to start investing and operating an active transportation network. A large amount of our GHG emissions are from transportation within our City. I am new to Barrie and find the roads are in poor condition, especially in the older parts of Barrie.

Does this budget increase even need any justification? Numerous roads/streets in Barrie are in terrible shape in need of immediate repair because of chronic budget underfunding. Also some roads are so clogged that traffic spills daily onto hwy 400 causing extremely dangerous conditions.

Way too much sand is used on roads during the winter. Where does it end up in our creeks and waterways. Also get rid of sidewalk snow removal except for the elderly.

Too much money spent on downtown. My road has not been resurfaced in the 43 yrs. I have lived here.

Way way behind in improving all the old roads.

Whenever roads are being improved... consideration should always be made to include more bike lanes. In general, I think Barrie is doing a great job of maintaining and improving our roads.

I am not sure where to place the money, but since it concerns modes of transportation, I decided to place it in this category. I would like to see a comprehensive network of paved trails (perhaps half the width of a road) to accommodate the increasing numbers E-scooters, E-bikes, E-skateboards and all other varieties of small, personal E-modes of transportation. We have sidewalks to accommodate pedestrians. Appropriate trails/roads - not just lanes - are needed for the very rapidly growing sector of personal E-modes of transportation. If possible, I would increase this budget by 10% to begin to accommodate this need. With the proper infrastructure, I suspect that many people would be quite happy to save money on gas and reach local destinations in a more economical fashion. At the moment, when riding a bicycle on the road, one often feels is risking one's life. Yet, many do so. I also

Apply the surplus road improvement in the Allandale community

Barrie roads need maintenance around railroad tracks!

Most of the streets in Barrie loosely resemble post world war 2 London. And not just side roads. Major thoroughfares are in rough shape.

Roads are a disaster.

We have a dedicated infrastructure fund. With a growing city and with a backlog of roads in need of repair this one should be increased.

My biggest grip is the Council and Administration over the past 20 years have regularly deferred preventive maintenance leading to more major replacement costs. All this to stay below the 3% tax increase thresh hold Council seems fixated on.

Inflation and currently poor road conditions require an increase here.

Patch work repair is costly-build sustainably.

The category description isn't clear if this includes capital works. My increase is based on capital projects. The infrastructure in this city is so far behind.

Spend the funds on repairs instead of building. We don't want any more traffic brought to the Essa and Veterans area. Please stop.

Maintenance and upgrading of critical infrastructure is important.

This year it has been good to see the road improvement projects to restore many north Barrie areas. Please continue to maintain our roads and clear the snow and prevent ice for safety.

So much work to be done.

Get creative in maintaining and operating. Eg: automation. Optimize scheduling of services. Notwithstanding, taxes are not a bad thing, as long as it is value for money, and Barrie is not overtaxed.

I believe that ensuring Barrie is climate change ready is critical for its future. We are already seeing increased frequency of 100 year storms and other related changes. Municipal infrastructure should be upgraded to beyond the 100 year storm benchmark and property owners should be provided with the tools to make their homes ready to withstand climate impacts. Municipal lobbying to other levels of government to provide grants for property upgrades (e.g. permeable paver installation, backflow valves, solar panels, insulation, heat pumps, electric charging stations ,etc) will also create a more resilient Barrie. Having said that, increased roads to support single use car traffic should not be a sole focus and active transportation must be encouraged, support and increased.

I think a review of foot traffic into physical libraries should be conducted. Why not work with publishers to establish online access to books. Perhaps with a temporary access code that residents can "check out" from the library. Having an online catalogue of books may reduce the need for large library facilities, while also minimizing the overhead to operate. While physical services (such as computer and printing access) are still important to offer, with the reduced facility requirements, library services can share physical space with other local community locations such as rec centers, place or worship, or even space at city hall.

Outdated and irrelevant.

Brick and Mortar libraries are basically in existence for social services only. They are not relevant for research and education anymore. This budget should be used towards actual social services that help those in need.

Libraries are an integral part of our community. Barrie should have at least one location in each quadrant of the city.

More online books would reduce homeless taking over downtown branch.

As long as the library needs to get their visitors from children to be read to by drag queens, I vote for more than 5% reduction in spending!

We need more "maker spaces" and locations like Innisfil Idea Lab has where creatives can produce small runs of items and A/B test before production - printing, embroidery machine (hats, shirts/bags) making vinyl signs, laser cutting, laser engraving of items etc.

Library use is declining. Reduce budget accordingly. Create a mobile library instead of wasting money on another branch in a strip mall.

Do people even use libraries anymore? Go online and mix the extreme spending. The library downtown is sucking our cities money to be empty.

COVID has demonstrated the value of public libraries in connecting communities, supplying reliable, accurate information, supporting the mental health of residents, skill-building etc. It is a municipal resource that is consistently undervalued and could be leveraged to a far greater degree in order to maximize the benefit for all residents.

Transit

Barrie Transit offers both specialized and conventional transit services to give Barrie residents an affordable and environmentally sustainable transportation option to their travel needs.

Increase spending with the idea we will add street cars and go beyond bussing... otherwise I would decrease this.

Increase to speed up electrification of buses and city fleets obviously, but also to add more adequate infrastructure for active transportation, and not just downtown (more people biking/walking is cheaper for residents and for the city, not to mention the reduction of carbon emissions and the much more efficient use of city space!)

Public transit should be free, not a profitable business. If more people had access to public transit they could actually get to work.

Pay to play. This should not be subsidized by the taxpayer. The system either has to run self sufficiently or be reduced or eliminated until it can do so!!

Instead of spending large amounts of money on our own transit system. Why not partner with uber, lift and offer short trip ride with them and keep a small transit fleet for long city routes. This would save money, plus create another job market in the city. Incentives can be given to green vehicles.

Increase ridership fees, let those who use transit foot the bill a little more.

Buses look mostly empty when I see them, perhaps cut down on the frequency of the service.

I see many empty or tiny capacity routes running every day. We should scale back routes during off peak hours.

Notice that the buses are running empty a lot of the time.

Get smaller busses, and more of them to make the transit system better.

Transit fares should be set at a level where rates cover actual ridership costs. It's okay if taxpayers cover CapEx costs, however transit users should fully cover operational costs. Taxpayers should not be subsidizing ridership.

With the advent of Uber and such people are looking at alternative ways to travel since the bus system is not fulfilling their needs and timelines. Why not explore partnerships with those types of organizations like Innisfil recently did? It helps people doing those jobs as well as providing more timely transportation. The bus system is essential for those who can't afford other means but it shouldn't be considered the only way to move people around. We need to get creative! What about having bicycle fueled transportation options partnerships with small operators in the summer like India and China? How are other Countries in the world doing it? Stop comparing with only National cities and be creative!

Perceived utilization of transit services is poor. Consider reallocating funds to better used routes or alternative service models.

Only main routes should be maintained because ridership is down.

While I believe public transit is important, I do believe we could reduce our budget and still meet the needs of travelers. Public transit should be as convenient as it is affordable. Since it is a subsidized means of travel for many residents, they should expect that wait times are acceptable considering the alternatives (purchasing/leasing a vehicle at much greater expense).

Barrie needs to start investing and operating an active transportation network. A large amount of our GHG emissions are from transportation within our City. Barrie has the able to be an active transportation leader, it just needs to start showing it more.

Improved transit and the addition of bike lanes to make Barrie less dependent on cars!!

While providing travel routes for those without cars is essential, the service needs updating. The cost that is being spent is not represented in the value returned from use. We need to find a creative way to allow for civilians to better access the city but with a smaller budget and a more specific travel destinations. Start looking at the grassroots level to see what would best support those who use and run the transportation service.

Buses are always empty. Rather see green scooter rentals like used in Ottawa etc.

Every bus that goes along my street is almost empty. Smaller buses?

I only recommend no budget increase until transit ridership rates resume to the pre-covid era. The budget should be held accordingly.

We need more "transit on demand" type services. 90% of the day I see large busses driving around empty all the time. A colossal waste of our resources.

Scrap the big gas guzzling and polluting busses and go to smaller vehicles with an "On demand" service. I believe Innisfil did this and saved a lot of money.

The busses run around empty because they are so inefficient. They either need to be greatly increased or reduced.

Too many little used buses...people in this city like to drive or walk.

A new strategy should be explored. I see almost 90% of buses with fewer than 5 people on the bus. And yet people still complain about and want more! No one is taking it so it needs a fresh new look.

Low ridership, excessive pollution.

Everyone needs travel, maintain spending.

The buses are running empty most of the time in Barrie - we have empty buses circling the city for no particular purpose.

It we are ever going to get people 'on board' with busses, we need fewer large busses; and more smaller busses with more frequent service.

Provide quality transit options where population density is increasing.

I don't see people on the bus.

Public transit is great but you focus too heavily on it - so many of us never ever use it and get nothing from the spending budget for it.

Build businesses downtown and around the waterfront. I'm not sure how it could be accomplished but moving some of the bars away from the downtown area would encourage people to frequent it and feel safe.

Direct this money to supporting local arts organizations. They are working hard to improve the life of residents and bring tourists to the area. They deserve the extra support.

Northwest Barrie is an often ignored corner when it comes to recreational support. We have a splash park that can only be used in summer months and a building with extremely limited use potential. Where are our gym machines, indoor pool or fitness classes for those in our area who truly need it? Why is the south end receiving yet another library facility when North Barrie is yet to see one? Many who don't drive live in our area as well as those with lower income levels. I'd hate to think that those lower income levels are what's influencing the lack of support. Why isn't our councillor advocating for these services? The issue was present pre-Covid so please don't use that as an excuse for this inequality.

Reduced for 2022. Important but not during the pandemic

CULTURE is what is hurting after the last year and a half. The arts need support more now than ever before!

Due to covid-19, fewer recreation services should be offered. Normally I would like to either maintain or increase this budget item, but that does not seem reasonable for 2022.

Recreation within the City of Barrie is poor, it needs a facelift to better promote it's facilities and to push its staff.

Need more detail on what actually gets allocated to this account. Library could accommodate this type of cultural awareness.

Our children, our seniors and our less fortunate fellow citizens need more assistance and programs to help them thrive and grow. Underfund this, and you substantially reduce the quality and potential of our citizens.

Increase Arts Funding immediately - thank you! We need a new Performance Centre. We need more funding in the Grants process and a return to individual arts grants. We need supports and programs that build youth arts engagement and growth and we should be working with organizations like the Coop to achieve better public-private partnerships.

I want to see an increase in the ARTS spending. Please devote AT LEAST 5% increase into arts spending.

While we can admire art work we feel way too much money goes into this for a city the size of Barrie...people can drive to Toronto who want a greater experience. Personally don't feel Barrie can AFFORD to be supporting art and live theaters with all the problems we have that require money!

Split up recreation and culture spending to better reflect discrete use, events, and user numbers

The services are the rec centers and culture are great for all age group keep spending.

I would like to see this increase to go to local arts organizations, which should not be merely another line item in this category.

Increase support for grassroot initiatives (e.g. woodworking club, other clubs and groups of interest) Coming out of the pandemic, Recreational and Cultural events will be essential for the region's well being and recovery.

We need more recreation centres in Barrie, especially if the City is going to grow at the rate mandated by the province.

Move the funds to Police for Mental Health Crisis response - share this surplus of \$871,519 back to the entities that have had their budget reduced.

More programs needed for youth.

Recreational programs fill up too fast.

Pools need to be enhanced as the population has grown

Pay the Rec centre instructors more. The classes used to be great but all the good instructors go to the better paying places. Increase their pay so we can have good instructors.

Support the arts more. Art affects all of us, daily. Barrie and Ontario is falling behind - one example of many: Barrie Central shutting down, quadmester system. ie: students feeding future art. It is a part of the spectrum of health and community of our citizen. Taxes are not a bad thing, as long as it is value for money, and Barrie is not overtaxed. On its own, what does \$1MM represent over 60,000 households + businesses? \$16/household, less with biz tax rev. As a thought experiment - how many 55+ year olds enjoy playing guitar, drums, piano, acting, singing, painting, potting etc. - even just privately - is it more than those of that age playing basketball, hockey, baseball, running etc. One would think so. All of them important recreation and leisure activities. It would contribute to mental health and well-being to have more support and outlets for 'public' and 'closet' artists.:)

In order to create a vibrant, attractive community increased cultural opportunities are essential. Although roads, sewers, etc are important infrastructure, no one moves to an area or takes pride in their community for their infrastructure (unless it's the quality and quantity of active transportation). Residents take pride in the community based on the sense of connection and the amenities they can enjoy.

Solid Waste Operations

This area provides curbside collection services for garbage, organics, recycling and leaf and yard waste, as well as hazardous waste collection and disposal. Oversees the operation and maintenance of the active landfill cell and the various environmental controls in place to ensure sustainable operations and compliance with environmental legislation.

Due to the growth of Barrie population, this is a very important public facility that needs a good budget.

Given that the 'garbage' trucks come by weekly for compost collection, why not just collect garbage weekly?

Barrie is one of the dirtier cities that I have lived in. I see garbage lying around on the sides of roads. Appliances dumped on the sides of roads, whole garbage bags thrown from cars and sitting on sidewalks. As we strive to discourage illegal dumping / littering, we need to have more FREE options. This is the FIRST city I have lived in that does not have any big bulk item curb side pickups for Free. Most other municipalities there are at least a half dozen days where you can leave big items for pick up. We need to spend more of our tax money on removing more waist from tax paying residences.

Provide one or two free curbside bulk pickups (furniture etc.) for tax paying residents. Not everyone has access to vehicles to get to the dump or drop items off at charity stores. Peel region (Mississauga) will pick up anything from the curb on regular garbage days at no charge for taxpayers by having the garbage trucks notify others that bulky items are at the curb, and they are picked up that day. This is value for taxpayers money.

We need additional funds to help divert waste and continue to invest in a strategy to close the landfill. Funds are needed to investigate joining a consortium of municipalities to build a green and eco-friendly incinerator.

I enjoy the new initiatives of clothes pickup, battery pickup keep these services going. Maintain it as is if we can recycle more may be worth investing into

Greater effort by the city must drive the message to households to reduce, repair and repurpose items, etc. before allowing items to go to the landfill.

Move the funds to the Police for Mental Health Crisis response - Create User fees for waste management increase compliance on recycling.

I think we need to look at managing our recyclable plastics locally. Where is our plastic going now? China?

Current recycling program is excellent.

If solid waste removal budget needs any increase, please design it so that it is user pay on a cost recovery basis. Don't make those of us who are conservative in our conservative in our purchasing and thus minimal in our waste production, have to pay for those who are not.

This needs to be a priority. When some people are getting only brown water and switches are being used. There is noticeable odor in downtown core and north end due to wastewater management.

Gardening expertise and forest management; building and maintenance training; knowledge is valuable! Also why not adopt a garden park area program for schools; or gardening competitions where people are given the opportunity to develop a flower bed (like the small patch at north Fox Run and Leacock)? It would engage the community and foster a feeling of all of us being part of our environment! And it could be done city-wide not just in Sunnidale arboretum.

Maintain because Parks should hopefully get increased usage.

Due to covid-19, increasing the city scape is important, as it is one of the cities best features, and allows residents to get out of the house and remain active, while maintaining safe distances from one and other.

Start maintaining trees on public boulevards, in front of peoples houses. Send pamphlets to tell residents how to maintain the city trees in front of their homes. provide deep root feeding and fertilization, and trimming to keep these trees healthy into maturity. We lose too many trees to neglect.

COVID has brought a fair amount of negativity to our doorsteps but the parks and naturals brought us nothing but positives... even before COVID.

No need to hang as many baskets. Plant perennials instead of annuals in permanent garden beds. Eco friendly, less labor intensive. Flowerbeds are beautiful but road maintenance and traffic movement is far more important.

More splash pads- safer and easier for families to cool down in the summer.

Let's have a beautiful city that people want to visit. Use the parks to showcase the plants and species native to this area as a tourist draw. Have more splash pads for the summers that kids can use.

We need a greener, healthier, more livable city. Barrie is a decade behind cities like Waterloo and many other similar sized cities when it comes to it's natural environment and trail system. We need larger interconnected green spaces for existing parts of the city and to invest in developing the old rail line into a trail system. We need a substantial budget increase in this department.

Have you seen the condition of Milligans Pond it's a disgrace. Is that how you treat land that was donated to you? We need a police or bylaw enforcement presence on a regular basis. I for one am sick of cleaning it up. How much \$\$ is spent on dumping fees?

Instead of using noise to reduce the population of Canada Geese in our parks, use other methods such as oiling eggs (making them not viable) or hire some workers to clean up the mess the geese make. Noise controls may reduce geese, but also reduces other species of birds in our parks too!

Can you spray for the caterpillars?

More parks and community services. Sport fields and maintenance. Now more than ever people need outlets.

The parks in Barrie are great as they are now. We have spent much money on the waterfront over the years lets take the time to pay off our debts.

As we are able to gather more, maintaining our parks and walking trails will be important to the well being of the region and also to tourism which will bring more money in. This is a spend money to make money situation.

Move these funds to Police and Mental Health Crisis Support - Develop a volunteer program for the parks.
