## 21-A-124 PRESENTATION REGARDING THE BARRIE POLICE SERVICE PROPOSED 2022 BUDGET REQUEST

Greg Ferguson, Chair of the Barrie Police Services Board provided an overview on the Barrie Police Service (BPS) 2022 Budget requirements. He advised that the strategic business plan requirements guided by several key factors to fulfill policing responsibilities, public expectations, evidence-based delivery of police services and increasing financial pressures.

Mr. Ferguson provided an outline of BPS 2022 Budget presentation to be presented by Chief of Police, Kimberly Greenwood. Mr. Ferguson commented that the 2022 budget requirement balances fiscal constraints while meeting the obligations under the *Police Services Act* and the expectations of the Community.

Chief Greenwood discussed slides concerning the following topics:

- A summary of BPS policing associated to community expectations, changing requirements and serious incidents;
- A systemic review of organizational cultures and systems;
- The budgetary challenges;
- A summary of the information technology enhancements;
- The new initiatives to assist case management, justice modernization, evidence-based policing and body-worn cameras;
- The following action items to implementation City's Community Safety Well-Being (CSWB) Plan;
  - Community Safety and Well-Being Officer;
  - Community Safety and Well-Being Police Unit;
  - Harm-Focused Policing Strategic Targeted and Researched (STAR); and
  - o The evolution of an Alternative Response Unit (ARU).
- The multi year staffing plan between 2014 to 2022;
- The 2022 Operating Budget;
- · The 2022 Capital Budget;
- The legislative impacts;
- A chart illustrating Barrie Police Service budget versus Barrie's population between 2011 to 2022; and
- A summary of the municipal funding requirement, 2.88% over 2021 Budget.

In closing, Chief Greenwood commented that the Barrie Police Service will continue to support and be an efficient police service to the community. She requested approval of the municipal funding portion of the Barrie Police Service 2022 Budget request.

Members of Council asked a number of questions of Chief Greenwood and received responses.

Councillor N. Harris stated that she was in consultation with the Integrity Commissioner regarding her Code obligations, including those that arise under the *Municipal Conflict of Interest Act*. Although, Councillor, N. Harris did not have a pecuniary interest in the matter that required her to abstain from voting on this matter, in accordance with her obligations under the Council and Committee Code of Conduct and upon advice of the Integrity Commissioner. ## 21-G-264 SUPPORT TO MOVE FORWARD WITH HOLLAND MARSH POLDER PHOSPHORUS RECYCLING FACILITY

WHEREAS the Holland Marsh Polder Phosphorus Recycling Facility is a proposed \$40 million capital project by York Region; and

WHEREAS the Facility will reduce phosphorous runoff into the Holland River and Lake Simcoe and thereby protect the Lake's watershed from algae growth, resulting in better protection for the region's aquatic habitats, increased ecosystem biodiversity and protection of drinking water sources; and

WHEREAS the federal government has announced funding of up to \$16 million for the Facility and York Region funding of up to \$25 million as part of their broader "Upper York Sewage Solution" plan; and

WHEREAS the June announcement and introduction of the *York Sewage Wastewater Act* by the Ontario Minister of the Environment, Conservation and Parks, which, if passed, "would put on hold the Environmental Assessment application for the Upper York Sewage" scheme;

#### NOW THEREFORE BE IT RESOLVED as follows:

- 1. That the City of Barrie express support towards York Region, the Government of Canada and the Province of Ontario to work collaboratively to move the Holland Marsh Polder Phosphorous Recycling Facility forward notwithstanding the "paused" status of the broader Upper York Sewage scheme, including proceeding to an Environmental Assessment for the Facility commencing in 2021.
- 2. That the City of Barrie request the Province of Ontario to support the funding of the Holland Marsh Polder Phosphorous Recycling Facility's construction.
- 3. That the Mayor send a letter outlining the above to the Federal Minister of Infrastructure and Communities; the Provincial Minister of the Environment, Conservation and Parks; the Lake Simcoe-area MPPs and MPs; York Region, Oro-Medonte, Innisfil, King Township, East Gwillimbury and local Councils and the Lake Simcoe Region Conservation Authority. (Item for Discussion 8.1, November 15, 2021)
