## BY-LAW NUMBER 2021-

A By-law of The Corporation of the City of Barrie to exempt all of Block 4, Plan 51M-1193 being Parts 9 through 23 (inclusive) on 51R-43276, City of Barrie, County of Simcoe being all of PIN 58091-3883 from Part Lot Control imposed by Section 50(5) of the *Planning Act, R.S.O. 1990, c.P.13.* 

**WHEREAS** Section 50, Subsection 7 of the *Planning Act, R.S.O. 1990, c.P.13* provides that, notwithstanding the provisions of Subsection 5, the Council of a municipality may by by-law provide that plans of subdivision or parts of them are designated in the by-law are not subject to Subsection 5 of Section 50;

**AND WHEREAS** KLM Planning Partners Inc. on behalf of the owner Mapleview Developments Ltd. has applied to the Council of The Corporation of the City of Barrie requesting that a by-law be enacted under the provisions of Subsection 7 of Section 50 of the *Planning Act, R.S.O. 1990, c.P.13;* 

**AND WHEREAS** the Council of The Corporation of the City of Barrie adopted Motion 12-G-190;

**AND WHEREAS** the Council of The Corporation of the City of Barrie deems it expedient to pass a by-law pursuant to the provisions of Subsection 7 of Section 50 of the *Planning Act, R.S.O. 1990, c.P.13* to exempt all of Block 4, Plan 51M-1193 being Parts 9 through 23 (inclusive) on 51R-43276, City of Barrie, County of Simcoe being all of PIN 58091-3883.

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

- 1. **THAT** Subsection 5 of Section 50 of the *Planning Act, R.S.O. 1990, c.P.13* does not apply to all of Block 4, Plan 51M-1193 being Parts 9 through 23 (inclusive) on 51R-43276, City of Barrie, County of Simcoe being all of PIN 58091-3883.
- 2. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.
