The purpose of this Memorandum is to provide members of Council with advance notice of the upcoming Public Information Centre (PIC) for the Bradford Street Corridor Municipal Class Environmental Assessment (EA).

The City of Barrie is undertaking a Schedule 'C' EA to identify long-range multi-modal transportation and streetscape improvements to support planned growth. The study is focusing on two specific areas: the Bradford Street corridor and the intersection pair of Tiffin Street/Bradford Street and Tiffin Street/Lakeshore Drive.

To advise the directly affected public of the PIC, a letter will be mailed on January 11, 2022, to agencies, businesses, property owners and tenants. To ensure Council has the same information as the public, this memo includes a copy of the mailout information.


