Hi Tammie,

I think I prefer just to watch the proceedings on the Youtube channel rather than participate on Zoom. Following are the comments and 2 questions which I would add to the process as my concerns.

In my opinion, the location and intensity of the proposed development surrounded mostly by low density and some medium density residential neighbourhoods seems out of place. I have 2 questions. The first about traffic impacts and the second about stormwater impacts.

- 1) Has the impact of increased traffic from the proposed development on traffic flow, patterns and issues been modelled or considered? The road configuration in the area, including Duckworth, Napier and St Vincent may mean that traffic flow will be forced East on Mountbatten into the lower density neighbourhoods rather than the "Arterial Road".
- 2) Does the analysis of the effect of more hard surfaces on the quantity and quality of the stormwater runoff incorporate the anticipated dynamics of climate change rather than the historical record.
