## **BY-LAW NUMBER 2022-**

A By-law of The Corporation of the City of Barrie to establish the lands described in Schedule "A" attached hereto (the "Lands") as a public highway, and to respectively name the highway Lakeshore Drive.

**WHEREAS** Section 10 of the *Municipal Act*, 2001, S.O. 2001, c. 25 as amended (the "Municipal Act, 2001"), provides that a single-tier municipality may pass by-laws respecting matters set out therein including, *inter alia*, public assets of the municipality acquired for the purpose of exercising its authority under the Municipal Act, 2001 or any other Act;

**AND WHEREAS** the Council of The Corporation of the City of Barrie deems it expedient to confirm its jurisdiction and to establish for the purposes of a public highway the Lands, and to respectively name the highway Lakeshore Drive.

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

- **1. THAT** the Lands are established as a public highway.
- **2. THAT** the Lands be named Lakeshore Drive, respectively, and that such name be affixed at the corners of the highway.
- **3. THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 11th of April, 2022.

READ a third time and finally passed this 11th of April, 2022.
