The Municipality is compliant with s.s. 59.1 (1) of the *Development Charges Act*, whereby charges are not directly imposed on June 17, 2014, between the City of Barrie and land owners within the Secondary Plan area (Salem and Hewitt's), which predates Bill 73 of the current Development Charges Act that came into effect January 1, 2016. The City has collected \$3,402,378 of voluntary contributions in 2021 as agreed through the MOU.
