

## **BY-LAW NUMBER 2022 -**

A By-law of The Corporation of the City of Barrie to establish 0.30M Reserve, Block 109, Plan 51M-1205, City of Barrie, County of Simcoe being all of PIN: 58727-0915(LT), Part Lot 13, Concession 11, being Part 1, Plan 51R-43258; City of Barrie, County of Simcoe being all of PIN 58727-1084(LT) and 0.30M Reserve Part Block 112, Plan 51M-1205; City of Barrie; County of Simcoe being Part of PIN 58727-0918 as public highway, and to respectively name the highway Shepherd Drive.

**WHEREAS** Section 10 of the *Municipal Act*, 2001, S.O. 2001, c. 25 as amended (the "Municipal Act, 2001"), provides that a single-tier municipality may pass by-laws respecting matters set out therein including, *inter alia*, public assets of the municipality acquired for the purpose of exercising its authority under the Municipal Act, 2001 or any other Act;

**AND WHEREAS** the Council of The Corporation of the City of Barrie deems it expedient to confirm its jurisdiction and to establish the following lands for the purposes of a public highway:

- a. 0.30M Reserve, Block 109, Plan 51M1205, City of Barrie, County of Simcoe being all of PIN: 58727-0915(LT);
- b. Part Lot 13, Concession 11, being Part 1, Plan 51R-43258; City of Barrie, County of Simcoe being all of PIN 587271084(LT); and
- c. 0.30M Reserve Part Block 112, Plan 51M-1205; City of Barrie; County of Simcoe being Part of PIN 58727-0918 as a public highway

and to respectively name the highway Shepherd Drive.

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

## 1. **THAT:**

- a. 0.30M Reserve, Block 109, Plan 51M1205, City of Barrie, County of Simcoe being all of PIN: 58727-0915(LT);
- b. Part Lot 13, Concession 11, being Part 1, Plan 51R-43258; City of Barrie, County of Simcoe being all of PIN 587271084(LT); and
- c. 0.30M Reserve Part Block 112, Plan51M-1205; City of Barrie; County of Simcoe being Part of PIN 58727-0918

are hereby each established as public highway, which highway is hereby named Shepherd Drive, and that such name be affixed at the corners of the highway.

2. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 2<sup>nd</sup> of May, 2022.

**READ** a third time and finally passed this 2<sup>nd</sup> of May, 2022.
