PURPOSE & BACKGROUND

- 2. The 2021 Annual Purchasing Activity Report reflects the procurement activity for the 2021 budget year, and the report is completed in accordance with the Procurement By-law that was in place during the purchasing activity period, being Procurement By-law 2019-015.
- 3. The Procurement By-law requires the Chief Procurement Officer to provide the following information:
 - a) An annual information report with the circumstances and details of any emergency purchases, with a procurement value equal to or greater than \$10,000 (see Appendix "A").
 - b) An annual information report with the circumstances and details of any non-standard procurements, with a procurement value equal to or greater than \$10,000 (see Appendix "B").

ANALYSIS

- 4. In 2021, the Purchasing Branch awarded 190 contracts amounting to \$180,152,257.02. Of this, Non-Standard Procurements and Emergency Purchases accounted for 9% of awards for a total of \$16,154,995.57.
