






Cost Sharing Breakdowns - 2021

Legislative Requirements

Ambulance Act

Municipal responsibilities

6 (1) Every upper-tier municipality shall,

- (a) except as otherwise provided by regulation, be responsible for all costs associated with the provision of land ambulance services in the municipality, subject to any grant made to the municipality under subsection 4 (3); and
- (b) be responsible for ensuring the proper provision of land ambulance services in the municipality in accordance with the needs of persons in the municipality. 1997, c. 30, Sched. A, s. 6; 1999, c. 9, s. 3 (1, 2); 2009, c. 33, Sched. 18, s. 1 (2, 3).





Legislative Requirements

Long-Term Care Homes Act (2007)

Southern municipal homes

119 (1) Every southern municipality that is an upper or single-tier municipality shall establish and maintain a municipal home and may establish and maintain municipal homes in addition to the home that is required. 2007, c. 8, s. 119 (1).

Agreement to help maintain home - south

121 (1) A southern municipality that is required or permitted to establish and maintain a municipal home but that is not maintaining a home or joint home may enter into an agreement with a municipality or municipalities maintaining a home or joint home to help maintain that home or joint home. 2007, c. 8, s. 121 (1).

Alternative ways to meet requirement

(2) The requirement in subsection (1) is met if the southern municipality participates in the establishment and maintenance of a joint home or helps maintain a municipal home or joint home under an agreement under section 121. 2007, c. 8, s. 119 (2).

Ontario's LTC Staffing Plan (2021-2025)

Funding More Direct Care Hours

Long-Term Care: Capital Redevelopment

Simcoe Manor Capital Development (2020)

- Base Construction Funding \$20.53 \$23.78 per diem
- CSF Adjustment \$1.50 per diem
- Planning Grant \$250K
- Transition Support \$300 per bed
- Georgian Manor Capital Development (2022)
- 16 Bed Expansion
- Fall Construction Start
- Base Construction + CSF + Planning Grant
