The purpose of this Memorandum is to provide members of Council advance notice of the second Public Information Centre (PIC) for the Bradford Street Corridor Municipal Class Environmental Assessment (EA) scheduled for June 22, 2022.

The City of Barrie is undertaking a Schedule 'C' EA to identify long-range multi-modal transportation and streetscape improvements to support planned growth. The study is focusing on two specific areas: the Bradford Street corridor and the intersections of Tiffin Street/Bradford Street and Tiffin Street/Lakeshore Drive. The second PIC will present community feedback received to date, an assessment of alternative solutions and identification of the preferred solution(s) for the Bradford Street corridor, a preliminary assessment of the Tiffin Street intersection alternative design concepts, and next steps.

To advise the directly affected public of the PIC, a letter will be mailed on June 6, 2022, to agencies, businesses, property owners and tenants. To ensure Council has the same information as the public, this memo includes a copy of the mailout information.
