The Active Transportation and Sustainability Committee met and reports as follow(s):

#### **NATURE BARRIE**

Dorothy McKeown, Nature Barrie provided a presentation on the Barrie Bird Friendly City Certification.

Ms. McKeown discussed slides concerning the following topics:

- A request to attain the support of the Committee;
- An introduction of the Barrie Bird Friendly team, members, member associations, and partners;
- A background of Nature Barrie;
- The Nature Canada certification aim;
- Reasons for the City of Barrie to achieve a Bird Friendly Certification;
- Why the City of Barrie qualifies for certification, the measures taken, the habitat protection, restoration, and climate resiliency;
- The Bluebird and Tree Swallow projects;
- Chimney Swifts and their habitat, survey statistics, and blitz counts;
- Saving the Barrie Central Collegiate chimney;
- Community outreach and education;
- What does the City of Barrie need to do to finalize certification;
- May 14, 2022 World Migratory Bird Day Proclamation;
- How can the City of Barrie help going forward; and
- Nature Canada criteria for a Bird Friendly City.

Members of the Committee asked questions of Ms. McKeown and received responses.

## SUPPORTING THE NEXT TERM OF ACTIVE TRANSPORTATION AND SUSTAINABILITY COMMITTEE

The Committee discussed supporting the next term of the Active Transportation and Sustainability Committee and brainstormed ideas, such as sharing priorities to focus on, including the Greenhouse Gas Reduction Strategy and the Cycle Barrie Infrastructure Program, setting agenda items for a meeting of the next term, as well as creating a transition document on priorities to focus on, proposed action items, where the Committee left off, a breakdown between active transportation and sustainability, and a formal budget for education and outreach activities.

Laurel Hoffarth discussed advertisement and promotion with the help of Living Green Barrie through social media avenues.

#### **CROMPTON PARK UPDATE**

Councillor Aylwin indicated that there were no updates to provide, and no further action was taken.

#### **STRAVA**

The Committee discussed the Strava app, how to get a link to the app on the Active Transportation portion of the City of Barrie's website, to advocate its ability to set up groups and clubs to encourage residents to use the app, and to promote active transportation.

Ms. Patterson-McGrath discussed getting assistance from staff for upcoming events within the City to make sure all forms are completed and all requirements are met.
