**BY-LAW NUMBER 2022 -**

**A By-law of The Corporation of the City of Barrie to deem certain Plans of Subdivision or parts thereof not to be a Registered Plan of Subdivision.**

**WHEREAS** The Council of The Corporation of the City of Barrie has authority pursuant to Section 50(4) of the *Planning Act*, R.S.O. 1990, c. P.13, as amended, to designate Plans of Subdivision or Parts thereof to be deemed not to be registered Plans of Subdivision for the purpose of Section 50(3);

**AND WHEREAS** the Council of The Corporation of the City of Barrie passed Motion 12-G-247;

**AND WHEREAS** Plan 51M-781 has been registered in the Registry Office for the Registry Division of Simcoe (No. 51) for eight (8) years or more.

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

1. **THAT** Lot 341 on 51M-781 designated as Parts 13 and 14 on 51R-43525 being all of PIN 58091-2259 (LT) and Block 493 on 51M-781 designated as Parts 2 and 15 on 51R-43525 being all of PIN 58091-2411 (LT) are hereby deemed not to be lots on a Registered Plan of Subdivision for the purposes of Section 50(3) of the *Planning Act*, R.S.O. 1990, c. P.13 as amended.
2. **THAT** Lot 342 on 51M-781 designated as Part 11 on 51R-43525 being all of PIN 58091-2260 (LT) and Block 492 on 51M-781 designated as Part 10 on 51R-43525 being all of PIN 58091-2410 (LT) are hereby deemed not to be lots on a Registered Plan of Subdivision for the purposes of Section 50(3) of the *Planning Act*, R.S.O. 1990, c. P.13 as amended.
3. **THAT** Block 488 on 51M-781 designated as Part 7 on 51R-43525 being all of PIN 58091-2406 (LT) and Block 489 on 51M-781 designated as Part 8 on 51R-43525 being all of PIN 58091-2407 (LT) are hereby deemed not to be lots on a Registered Plan of Subdivision for the purposes of Section 50(3) of the *Planning Act*, R.S.O. 1990, c. P.13 as amended.
4. **THAT** Lot 217 on 51M-781 designated as Part 5 on 51R-43525 being all of PIN 58091-2135 (LT) and Block 487 on 51M-781 designated as Part 6 on 51R-43525 being all of PIN 58091-2405 (LT) are hereby deemed not to be lots on a Registered Plan of Subdivision for the purposes of Section 50(3) of the *Planning Act*, R.S.O. 1990, c. P.13 as amended.
5. **THAT** Block 485 on 51M-781 designated as Part 3 on 51R-43525 being all of PIN 58091-2403 (LT) and Block 486 on 51M-781 designated as Part 4 on 51R-43525 being all of PIN 58091-2404 (LT) are hereby deemed not to be lots on a Registered Plan of Subdivision for the purposes of Section 50(3) of the *Planning Act*, R.S.O. 1990, c. P.13 as amended.
6. **THAT** this By-law shall come into full force and take effect upon registration in the Registry Office for Simcoe County (51), subject to the provisions of Section 50(26), (28) and (29) of the *Planning Act*, R.S.O. 1990, c. P.13 as amended.

**READ** a first and second time this 6<sup>th</sup> day of June, 2022.

**READ** a third time and finally passed this 6<sup>th</sup> day of June, 2022.
