RE: EN1271 MAPLEVIEW DRIVE EAST (YONGE STREET TO PRINCE WILLIAM WAY) TRANSPORTATION IMPROVEMENTS (WARD 9, 10)

DATE: June 13, 2022

The purpose of this memorandum is to provide members of the Council with information concerning the upcoming Public Information Centre (PIC) for the Mapleview Drive East (Yonge Street to Prince William Way) transportation improvement project.

Capital project EN1271, which includes the Yonge Street / Mapleview Drive East intersection and approximately 1.2 km of corridor length along Mapleview Drive East, is identified within the Multi-Modal Active Transportation Master Plan (MMATMP). The improvements within this project scope include:

- an increase from two (2) lanes to four (4) lanes along Mapleview Drive East,
- a raised median,
- upgrades to the existing at-grade rail crossing, and
- stormwater management system enhancements.

Intersection Pedestrian Signals will be implemented at Royal Jubilee Drive, and a full traffic control signal will be implemented at the future Kneeshaw Drive and Lilly Drive intersection.

Virtual Public Information Centre

A virtual PIC will be uploaded to the City's website on Wednesday, June 22nd, 2022 on the City's project website. The purpose of the PIC is to engage the community and advise residents on the upcoming construction stages of the project. The project is currently in the 90% detailed design phase. The construction is scheduled to start in 2024 and is expected to be completed by November 2025.

A notice of the virtual PIC was distributed to residents adjacent to the project in the St Paul's Crescent / Sun King Crescent areas and was also placed in the Barrie Advance (see Appendix A).
