



**BY-LAW NUMBER 2022 -**

**A By-law of The Corporation of the City of Barrie to exempt Part of Block 2, Plan 51M-1193 being Parts 1 through 8 on Plan 51R-43584 subject to an easement in gross as in SC1712097, City of Barrie, County of Simcoe, being part of PIN: 58091-4626 (LT) from Part Lot Control imposed by Section 50(5) of the *Planning Act, R.S.O. 1990, c.P.13*.**

**WHEREAS** Section 50, Subsection 7 of the *Planning Act, R.S.O. 1990, c.P.13* provides that, notwithstanding the provisions of Subsection 5, the Council of a municipality may by by-law provide that plans of subdivision or parts of them are designated in the by-law are not subject to Subsection 5 of Section 50;

**AND WHEREAS** KLM Planning Partners Inc. on behalf of the owner Mapleview Developments Ltd. has applied to the Council of The Corporation of the City of Barrie requesting that a by-law be enacted under the provisions of Subsection 7 of Section 50 of the *Planning Act, R.S.O. 1990, c.P.13*;

**AND WHEREAS** the Council of The Corporation of the City of Barrie adopted Motion 12-G-190;

**AND WHEREAS** the Council of The Corporation of the City of Barrie deems it expedient to pass a by-law pursuant to the provisions of Subsection 7 of Section 50 of the *Planning Act, R.S.O. 1990, c.P.13* to exempt Part of Block 2, Plan 51M-1193 being Parts 1 through 8 on Plan 51R-43584 subject to an easement in gross as in SC1712097, City of Barrie, County of Simcoe, being part of PIN: 58091-4626 (LT).

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

1. **THAT** Subsection 5 of Section 50 of the *Planning Act, R.S.O. 1990, c.P.13* does not apply to Part of Block 2, Plan 51M-1193 being Parts 1 through 8 on Plan 51R-43584 subject to an easement in gross as in SC1712097, City of Barrie, County of Simcoe, being part of PIN: 58091-4626 (LT).
2. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 21<sup>st</sup> day of September, 2022.

**READ** a third time and finally passed this 21<sup>st</sup> day of September, 202.
