

## COMMITTEE OF ADJUSTMENT PUBLIC NOTICE OF HEARING SUBMISSION NO. B31/22

**TAKE NOTICE** that an application has been received from **Innovative Planning Solutions**, **c/o Kyle Galvin on behalf of 2779246 Ontario Inc.** for consent under Section 53 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended for a consent to a conveyance of property for the creation of an easement.

**IN THE MATTER OF** the premises described as INNISFIL CON 12 S PT LOT 11 and known municipally as **571 Huronia Road** in the City of Barrie.

The property is zoned Light Industrial (LI).

The application, if granted by the Committee of Adjustment, will serve to permit the creation of easements for access purposes.

The proposed easement (shown on the attached sketch) will have an area of 381.57 square metres and a lot frontage of 15 metres on Huronia Road.

The proposed easement (shown on the attached sketch) will have an area of 876.16 square metres and a lot frontage of 43.6 metres on Mapleview Drive East.

The subject application is being considered concurrently with application B30/22.

**TAKE FURTHER NOTICE** that the Committee of Adjustment public hearing has been scheduled for **Wednesday, October 19, 2022.** This public meeting will be held in a virtual forum with electronic participation. The application and others will be heard commencing at **5:00 p.m. via ZOOM.**

Notices are sent to all property owners shown on the last assessment records within 60m of the subject property.

Although this is a public hearing, you are not required to attend unless you wish to speak to the application. If you have specific comments regarding this application, you may submit comments to the Secretary-Treasurer of the Committee of Adjustment at cofa@barrie.ca.

Every attempt should be made to file your submission six days prior to the Public Hearing date. Notice of the decision will be provided to each person who appeared in person or by authorized representative at the hearing and who files with the Secretary-Treasurer a written request for notice of the decision. If you do not attend, the hearing will proceed in your absence and you will receive no further notice. You must register and attend the hearing to receive further notice.






## COMMITTEE OF ADJUSTMENT KEY MAP SUBMISSION NO. B31/22 571 HURONIA ROAD
