

COMMITTEE OF ADJUSTMENT PUBLIC NOTICE OF HEARING SUBMISSION NO. B45/22

TAKE NOTICE that an application has been received from **KLM Planning Partners Inc.**, **c/o Keith MacKinnon on behalf of Mapleview Developments Inc.**, **c/o Dino Sciavilla** for consent under Section 53 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended for a consent for creation of an easement for shared amenity.

IN THE MATTER OF the premises described as CON 12 S PT LOT 16 and known municipally as **750 Mapleview Drive East** in the City of Barrie.

The property is zoned Residential Multiple Dwelling Second Density with Special Provision No. 569 (RM2)(SP-569).

The application, if granted by the Committee of Adjustment, will serve to permit the creation of an amenity easement for the purpose of shared amenity space in favour of Block 6, 8, 16, 17 and 23, 51M-1193. The property is subject to Site Plan Application D11-023-2021.

The proposed easement (shown on the attached sketch as Parts 2, 3, 4 and 5) will have an area of 1,369.2 square metres.

The subject application is being considered concurrently with applications B33/22, B34/22, B35/22, B41/22, B42/22, B43/22 and B44/22.

TAKE FURTHER NOTICE that the Committee of Adjustment public hearing has been scheduled for **Wednesday, November 9, 2022.** This public meeting will be held in a virtual forum with electronic participation. The application and others will be heard commencing at **5:00 p.m. via ZOOM.**

Notices are sent to all property owners shown on the last assessment records within 60m of the subject property.

Although this is a public hearing, you are not required to attend unless you wish to speak to the application. If you have specific comments regarding this application, you may submit comments to the Secretary-Treasurer of the Committee of Adjustment at cofa@barrie.ca.

Every attempt should be made to file your submission six days prior to the Public Hearing date. Notice of the decision will be provided to each person who appeared in person or by authorized representative at the hearing and who files with the Secretary-Treasurer a written request for notice of the decision. If you do not attend, the hearing will proceed in your absence and you will receive no further notice. You must register and attend the hearing to receive further notice.


