RECOMMENDED MOTION

1. That in accordance with Mayor, A. Nuttall's recommendations,

- a) The Reference Committee and Advisory Committee structure attached as Appendix "A" to Staff Report LCS007-22, be approved;
- b) The Chairs and memberships to the Committees attached as Appendix "B" to Staff Report LCS007-22, be approved;
- c) Planning Act Public Meetings be held at the Affordability Committee;
- d) Consideration of Planning Act applications matters related to development applications be considered by General Committee; and
- e) The Planning Committee be dissolved to allow for increased flexibility of scheduling additional meetings as required to address Planning and other Corporate matters.
- 2. That the City Clerk be authorized to make amendments to Procedural By-law 2019-100 to address the new committee structure and changes.
- 3. That a Mayor's Priority and Planning Task Force be established as identified in the Memorandum from Mayor Nuttall attached as Appendix "C" to Staff Report LCS007-22.
- 4. That the Legislative and Court Services Department be authorized to advertise for external candidates for appointment to those committees for which advertisements have not previously been circulated as identified in Appendix "D" to Staff Report LCS007-22.

PURPOSE & BACKGROUND

5. This Report is being presented by the City Clerk, on behalf of Mayor Alex Nuttall for the purpose of presenting his recommendations for the Reference and Advisory Committee Structure for the 2022-2026 Term of Council as well as changes to addressing Planning Act application Public Meetings and consideration of the associated development applications.

ANALYSIS

Reference Committees

- 6. In general, the role of a Reference Committee is to provide advice and guidance to City Council (through General Committee) on the direction and nature of policy development and to complete fact finding and detailed analysis of the matters before the Reference Committee. Reference Committees deal with matters within the duties of the individual Committee, matters referred to it by City Council, and/or items of an Advisory Committee that reports to it. The business dealt with by each Reference Committee must fall within the duties of the Reference Committee under the Procedural By-law.
- 7. General Committee met on Saturday, December 3, 2022, to determine Council's Strategic Priorities for the 2022-2026 Term of Council. The priorities are as follows (pending final Council approval on December 14, 2022):
 - Affordable Place to Live
 - Community Safety
 - Thriving Community
 - Infrastructure Investments
 - Responsible Governance
- 8. Mayor Nuttall has proposed a reference committee structure with four (4) committees, each composed of two to three members of City Council (plus the Mayor and Deputy Mayor as ex-officio members). The Reference Committee and Advisory Committee Structure recommended as further outlined in Appendix "A" of Staff Report LCS007-22 aligns with these priorities.
- 9. The proposed Reference Committees are slightly smaller in membership than past years. However, as in the past, all members of Council will be invited to attend these meetings and participate in Reference Committees as non-voting members.
- 10. Mayor Nuttall has also provided recommendations for the Chairs of the Advisory Committees as well as any additional council membership as outlined in the proposed Committee mandates.
- 11. The current Advisory Committees will remain at this time with the exception of the Seniors Advisory Committee. Due to the synergies with the Accessibility Advisory Committee, as well as internal feedback and completion of the Age Friendly Plan, these two committees will be merged. The proposed mandate of this Committee would be:
 - To champion issues related to the provision of an accessible community on behalf of all Barrie's citizens
 - To represent and provide advice on seniors' perspectives on municipal matters
- 12. Reference and Advisory Committees generally occur monthly or as required depending on the business that is at hand for the Committees to consider. A schedule of these meetings will be established with the Clerk and the Chairs. The Clerk in consultation with the Chairs will cancel or schedule extra meetings as required.

13. Advertisements for citizen participation for the non-discretionary committees are detailed in Appendix "D" to Staff Report LCS007-22. It is recommended that the Clerk commence this process.

Committees

14. Attached as Appendix "B" to Staff Report LCS007-22 is a listing of all of the proposed appointments of Council members to Committees as well as the proposed Committee Chairs. There are minor changes to appointments previously approved by Council through motion (22-G-168) on November 30, 2022. These changes are highlighted in the Appendix.

Mayor's Priorities and Planning Task Force

15. Mayor Nuttall is recommending the establishment of a Mayor's Priority and Planning Task Force. The purpose and mandate of this Task Force is discussed in the Memorandum from Mayor Nuttall attached as Appendix "C" to Staff Report LCS007-22.

Planning Committee

- 16. Given all the recent legislative changes through Bill 23 and 109, Planning Act applications will need to be dealt with in a more expeditious manner.
- 17. It is recommended that the Planning Act Public Meetings be moved to the Affordability Committee. The Advisory Committees have fewer members, so there is more flexibility in scheduling additional meetings to conduct Planning Act Public meetings as a quorum of Council is not required.
- 18. It is also recommended that staff reports associated with development applications would now be considered by General Committee. Again, this provides flexibility in scheduling additional meetings as required to address these staff reports as well as other matters that are not planning in nature.

Procedural By-law Updates

19. In order to facilitate the changes to the Committee structure proposed, it is recommended that the Clerk be authorized to make the applicable by-law changes to implement the new Committee structure. The proposed by-law will be presented on a future City Council agenda, once finalized.

ENVIRONMENTAL AND CLIMATE CHANGE IMPACT MATTERS

20. There are no environmental or climate change impact matters directly related to the recommendation concerning the structure of committees and appointment of members of Council to the Committees.

ALTERNATIVE(S)

21. The following alternatives are available for consideration by General Committee.

Alternative #1: No alternatives are being presented as the recommendations are those of Mayor Nuttall.

FINANCIAL

22. Currently, the average amount of staff hours required to support each Reference and Advisory Committee varies according to the frequency, timing and amount of agenda material required for each committee meeting. At this time, it is not anticipated that the proposed changes will result in additional resource requirements related to Committee support. However, staff will report back on additional resourcing to support the new Committee structure, as required.

23. The content of this Report is linked to all of the 2022-2026 Council Strategic Priorities that are pending final approval by Council, as the proposed Committee structure directly aligns with Council's priorities.

At the request of the Deputy Mayor, I am forming a task force to assist with the prioritization of the workload in the reference committees. As Reference Committees are working through their individual mandates, this taskforce will be utilized to assist in the following collaborative initiatives:

- The creation and recommendation of measurables for each reference committee;
- The coordination of topics that may reach beyond the purview of one committee and its mandate;
- The prioritization of deliverables within the structure of reference committees;
- Transparent alignment of the subject matter within committees with the approved strategic plan as of the December 3, 2022, General Committee meeting; and
- Open reporting of the business discussed at the Committee to City Council monthly.

The creation of this task force has been in response to a concern that without a priorities and planning task force, City Council may not be able to achieve its goals outlined in its Strategic Plan.

All members of Council are responsible for this including the Mayor, through our participation in the Reference Committees, General Committee and Barrie City Council.

In an effort to encourage increased collaboration at the early stages of policy creation and in recognition that some matters may be aligned with more than one Reference Committee Mandate, I am forming this task force to help guide the reference committees forward.

The taskforce will consist of each of the Chairs of the Reference Committee and the Deputy Mayor. Should the individual who serves in each of these roles change, the in-coming Chair or Deputy Mayor would resume the responsibilities and replace the current member.

A report from each meeting will be provided by the Deputy Mayor to the Mayor's Office and the Chair of the Taskforce will also provide an update monthly as previously stated.

Based on recommendations of the Deputy Mayor, the Chair of Community Safety will assume the Chair of the Mayor's Taskforce on Priorities and Planning (Reference Committees).

The creation of this task force aligns with Council's Priority regarding Responsible Governance.
