# PRESENTATION BY THE BARRIE POLICE SERVICE CONCERNING THE COMMUNITY SAFETY AND WELL-BEING PLAN

Police Chief, Kimberley Greenwood of the Barrie Police Service provided a presentation regarding the City of Barrie's Community Safety and Well-Being Plan.

Police Greenwood discussed slides concerning the following topics:

- The Barrie Police Service 2022-2025 Strategic Plan Priorities;
- The City of Barrie 2022-2026 Strategic Priorities;
- The alignment between the City of Barrie and Barrie Police Service Strategic Priorities;
- An overview of the City's 2021-2024 Community Safety and Well-Being Plan;
- The risk factors identified for the Plan that included fragile conditions and services under stress;
- The Plan action partners;
- The action items:
  - A safer Barrie by working together;
  - Connected and safe communities;
  - Safety is for everyone; and
  - Prepared and protected.
- An overview of the Barrie Community Services Campus and its core partners and agencies available for support;
- A summary of the Community Safety and Policing Grant to support the One Stop Shop Project;
- Examples of other municipalities' best practices and established Community Campuses and Ontario Justice Centres;
- The Plan phases:
  - o One Research and Development April 2022 to March 2023;
  - o Two Implementation April 2023 to March 2024; and
  - Three Operations and Measurement April 2024 to March 2025.
- An overview of the Barrie Health Accord including supply mapping, advanced mapping analysis, and navigation platform adoption.
