RECOMMENDED MOTION

1. That the schedule of City Council and General Committee meetings for 2023 to 2026 attached as Appendix "A" to Staff Report LCS003-23, be approved.

2. That the City Clerk in consultation with the Mayor be authorized to alter the schedule of City Council and General Committee meetings as required.

PURPOSE & BACKGROUND

- 3. The purpose of this Staff Report is to recommend a schedule of meetings for the years 2023 to 2026.
- 4. City Council at its meeting on June 6, 2022, adopted the following as part of motion 22-G-117 as follows:

COUNCIL MEETING SCHEDULE

- That Standing Committee and Council meetings be moved to Wednesday evenings at 7:00 p.m., effective for the 2022-2026 Council term, with the Procedural By-law being amended accordingly.
- 5. The Legislative and Court Services Branch maintains a schedule of meetings for both City Council and General Committee. Currently, Articles 4.1 and 12.3 of Procedural By-law 2019-100 as amended governing the procedures of City Council specify that regular meetings of City Council and Standings Committee shall be held on Wednesdays, except during the summer recess and the weeks when Monday is a holiday and when otherwise determined by City Council.

ANALYSIS

- 6. The proposed schedule of meetings attached as Appendix "A" alternates City Council and Standing Committee (General Committee) meetings. Meetings have been included on the schedule for each Wednesday evening, with the following exceptions based on traditional exemptions:
 - a) Weeks where Monday is a holiday (i.e., Family Day, Easter Monday, Victoria Day, Labour Day, Thanksgiving);
 - b) March Break;
 - c) Accommodations for the 2026 Municipal Election; and
 - d) One double meeting the second week in August.
- 7. While the proposed changes will maintain a similar number of meetings to the previous Term of Council, there are provisions contained within the Procedural By-law which would permit the scheduling of additional meetings, with appropriate notice, if required. These provisions have been utilized in the past on a relatively regular basis throughout the year to schedule early meetings or additional meetings, as they may be required given the nature of decision-making requirements for the Corporation and any associated timing constraints.
- 8. It is proposed that the City Clerk in consultation with the Mayor have the authority to alter the schedule of meetings as required. This delegated authority would resolve the need to obtain Council approval if meetings identified in Appendix "A" to Staff Report LCS003-22 need to be cancelled or added.

ENVIRONMENTAL AND CLIMATE CHANGE IMPACT MATTERS

9. There are no environmental and/or climate change impact matters related to the recommendation.

ALTERNATIVES

10. The following alternatives are available for consideration by General Committee:

Alternative #1:

General Committee could decide to add and/or delete meetings as deemed necessary. Staff have proposed the traditional schedule of meetings with the alternating of General Committee and City Council, for the four year term.

There are provisions contained with the Procedural By-law which would permit the scheduling of additional meetings, with appropriate notice. At any point in the term of City Council, the deletion of specific meetings could be considered.

Alternative #2:

General Committee could add in 2 additional meetings immediately following the 2026 Municipal Election and before the Inaugural Meeting of the 2026 to 2030 City Council. November 14, 2026 is the last day of the 2018-2022 Council term.

In 2022 only one meeting cycle was scheduled after Labour Day and one meeting prior to the start of the new Term of Council in November. Depending on the composition of the new City Council for 2022-2026, City Council's actions may be restricted as a result of the "lame duck" provisions.

Alternative #3:

General Committee could delete all of the meetings scheduled for the period after September 23, 2026 and commence meetings again at the beginning of the new term of Council.

Most recently, limited matters have been presented during this period due in part to the restrictions on decision-making contained within the *Municipal Act*. Should General Committee and City Council decide to proceed with this alternative and delete these meetings now, there are provisions contained in the Procedural By-law which would permit the scheduling of additional meetings, with appropriate notice, if required in 2026.

11. There are no direct financial implications associated with the recommendations in this Report.
