TAKE NOTICE that an application has been received from **MHBC Planning, c/o Kory Chisholm on behalf of 2144176 Ontario Limited, c/o Ardy Nikzad** for consent under Section 53 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended for a consent to a conveyance of property for creation of an easement for access.

IN THE MATTER OF the premises described as PLAN 51M832 BLK 19 and known municipally as **800 Yonge Street** in the City of Barrie.

The property is zoned General Commercial with Special Provision No. 348 (C4)(SP-348).

The application, if granted by the Committee of Adjustment, will serve to permit the creation of an easement over the retained lands in favour of the severed lands subject to consent application B22/22 located at 800 Yonge Street for access purposes.

The proposed easement (shown on the attached sketch) will have an area of 3,166.34 square metres and a width of approximately 15 metres.

The subject application is being considered concurrently with application B22/22.

TAKE FURTHER NOTICE that the Committee of Adjustment public hearing has been scheduled for **Tuesday, February 28, 2023**. This public meeting will be held in a virtual forum with electronic participation. The application and others will be heard commencing at **5:00 p.m. via ZOOM**.

To participate in the virtual planning meeting, you will need access to a computer with internet service or a telephone. For information on how to register for the meeting please go to: www.barrie.ca/cofa.

Notices are sent to all property owners shown on the last assessment records within 60m of the subject property.

Although this is a public hearing, you are not required to attend unless you wish to speak to the application. If you have specific comments regarding this application, you may submit comments to the Secretary-Treasurer of the Committee of Adjustment at cofa@barrie.ca.

Every attempt should be made to file your submission six days prior to the Public Hearing date. Notice of the decision will be provided to each person who appeared in person or by authorized representative at the hearing and who files with the Secretary-Treasurer a written request for notice of the decision. If you do not attend, the hearing will proceed in your absence, and you will receive no further notice. You must register and attend the hearing to receive further notice.

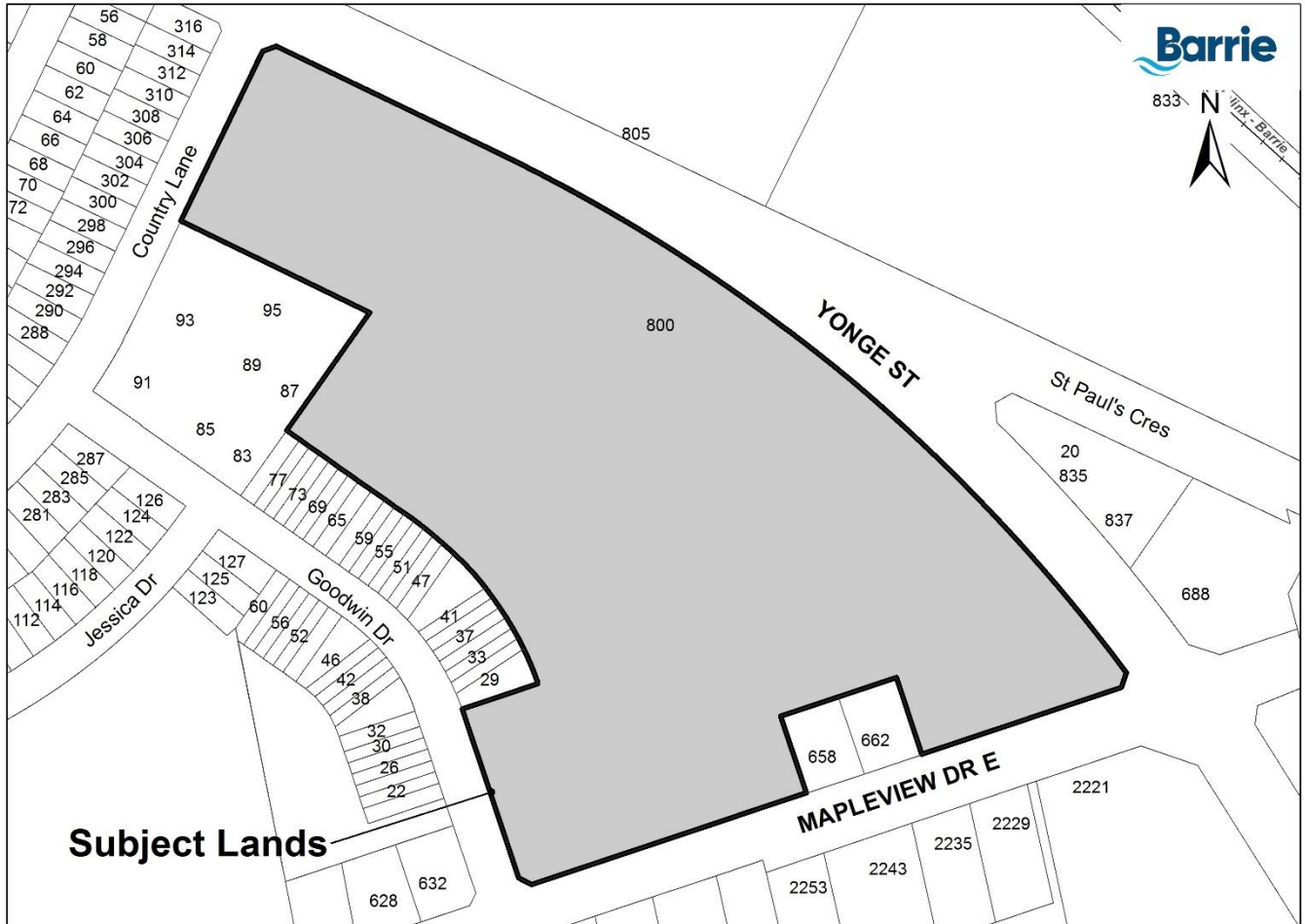

800 YONGE STREET

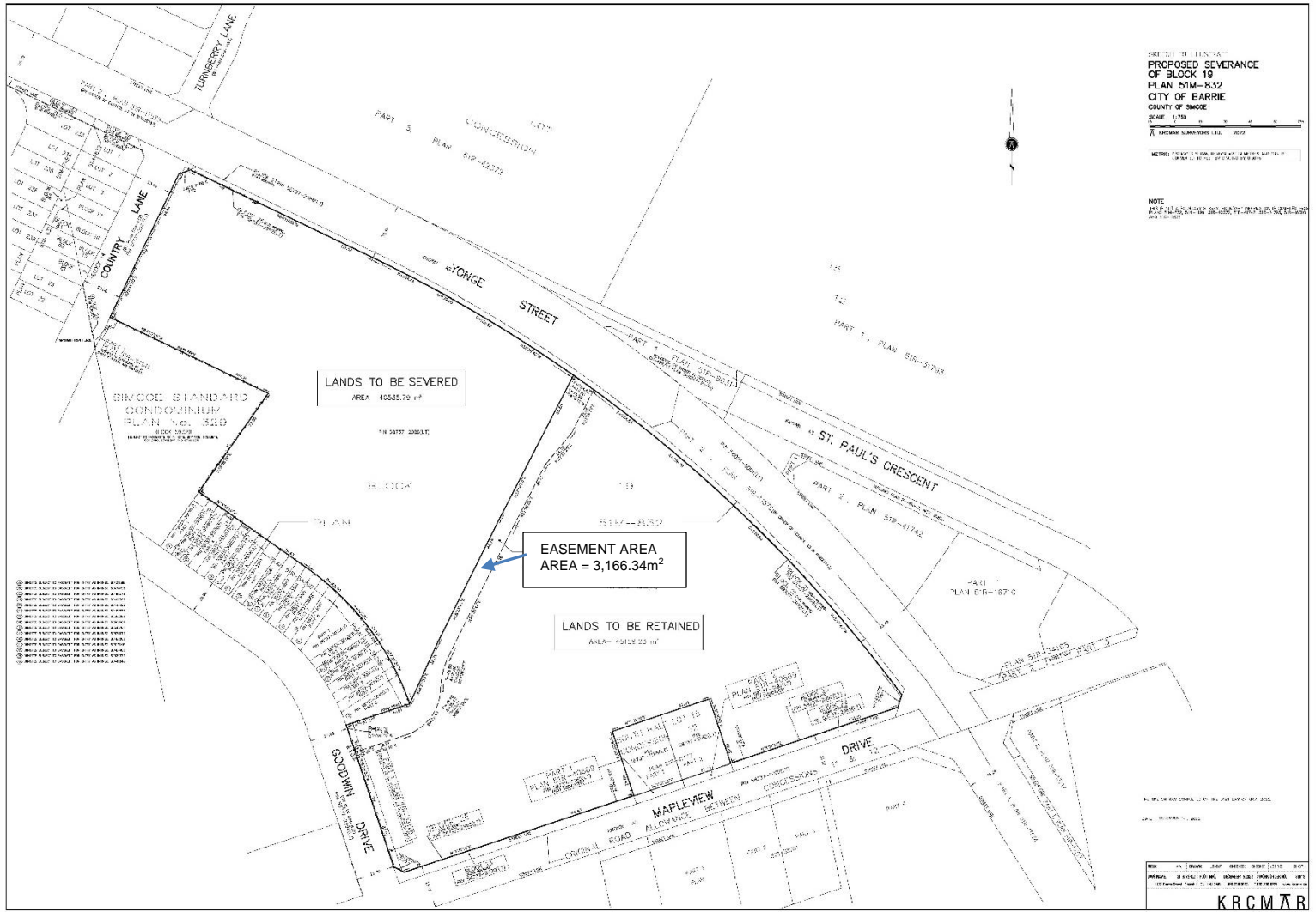
