21-G-052 CLEAN AIR ALLIANCE - PHASE-OUT OF GAS FIRED POWER PLANTS IN ONTARIO

WHEREAS the Government of Ontario is planning to increase electricity generation and greenhouse gas pollution from Ontario's gas-fired power plants by more than 300% by 2030 and by more than 400% by 2040, reversing more than a third of the greenhouse gas pollution reductions achieved by phasing out our coal-fired power plants; and

WHEREAS Greenhouse gas pollution is causing temperatures in Canada to rise at more than double the rate of the rest of the world, causing impacts to the operations and citizens of the City of Barrie; and

WHEREAS one of the City of Barrie's strategic priorities is fostering a safe and healthy City by building a greener Barrie and adapting and mitigating climate change; and

WHEREAS the City of Barrie is taking measures to mitigate and adapt to the climate impacts caused by increasing greenhouse gas pollution; and

WHEREAS the planned increase in electricity-related greenhouse gas pollution will reduce the effectiveness of the City of Barrie's greenhouse gas reduction efforts; and

WHEREAS there are feasible, cost-effective alternatives to increasing gas-fired electricity generation without increasing greenhouse gas pollution at costs well below the current price for Ontario's nuclear energy (9.6 cents/kWh), including:

- Energy efficiency investments;
- Low-cost, distributed, renewable energy, providing employment in Ontario communities and restoring our leadership in this industry;
- The purchase of low-cost power offered by the Province of Quebec from its existing hydroelectric generating stations; and
- Using Quebec's system of reservoirs like a giant battery to back-up made in Ontario renewable power and eliminating the need to use gas-fired power plants for this purpose.

THEREFORE, BE IT RESOLVED as follows:

- 1. That the City of Barrie requests the Government of Ontario to place an interim cap of 2.5 megatonnes per year on the greenhouse gas pollution from Ontario's gas-fired power plants and develop and implement a plan to phase-out all gas-fired electricity generation by 2030 to help the City of Barrie, the Province of Ontario and the Government of Canada to meet their climate targets.
- 2. That a copy of the resolution be sent to the Premier of Ontario, the Minister of Energy, Northern Development and Mines, the Minister of the Environment, Conservation and Parks, the Minister of Health, all local MPPs and MPs, the Ontario Big City Mayors Caucus (OBCM), the Association of Municipalities of Ontario, the President of Hydro Quebec and the Premier of Quebec.

- 3. That the Purchaser be permitted to submit a Zoning By-law Amendment application for the Subject Property and include it in development applications.

 - Require employers in Ontario to provide no less than five paid sick days annually to workers, after three months of employment, through amendments to the *Employment* Standards Act, 2000, or through a different mechanism;
 - b) Provide necessary funding, fiscal relief, and/or support to employers so that all workers in Ontario have access to no less than ten paid sick days annually in the event of a declared infectious disease emergency such as the COVID-19 pandemic; and
 - c) Ensure all workers in Ontario have access to protected and paid emergency leave so that care can be provided to children, parents, and/or other family members who may become ill.
- That a copy of the resolution be forwarded to the Premier of Ontario, the Minister of Labour, Trades Skills and Development and local Members of Provincial Parliament. (Item for Discussion 8.3, March 8, 2021)

21-G-060 A REQUEST FOR EXEMPTION FROM REGULATORY BY-LAW 2010-036 AS AMENDED, TO PERMIT AN INDOOR GUN RANGE AT 342 KING STREET, BARRIE (WARD 7).

That staff in the Legislative and Court Services Department be directed to work with the proponent, the Chief Firearms Office of Ontario, and Barrie Police Service to identify applicable regulations, the potential amendments to City of Barrie by-laws that would be required to provide an exemption to allow for an indoor gun range at 342 King Street, as well as implications of the proposed gun range and provide notification of this proposal to properties in the commercial King Street area to allow for input, and report back to General Committee.

ECONOMIC RECOVERY ACTION PLAN **UPDATE PROGRAM** 21-G-061 APPROVALS FOR **BUSINESS** IN THE **PARKS** AND **PATIOS EVERYWHERE**

- 1. That Staff Report ECD002-21 concerning an update on the Barrie COVID-19 Economic Recovery Action Plan be received as a follow-up to motions 20-G-061, 20-G-099 and 20-G-177.
- 2. That the Business in the Parks Pilot Program be extended until December 31, 2021, and that Sunnidale Park be added to the authorized list of Parks included in the Business in the Parks Pilot Program.
- 3. That the program parameters, application process and operating criteria for the Patios Everywhere Program as outlined in Appendix "B" to Staff Report ECD002-21 be approved for the 2021 patio season with a start date of April 1, 2021 ending on November 30, 2021 and that the provisions governed in Business Licensing By-law 2006-266, as amended, shall not apply.
- 4. That Schedule M of the Fees By-law 2021-20 be amended to add Sunnidale Park to the list of parks to which the private function permit fees apply.
- 5. That the Downtown BIA Patio Program be permitted to operate from April 1, 2021 to November 30, 2021 with exceptions to accommodate Dunlop Streetscape deficiency repairs and winter snow events that may require temporary patio removal.
- 6. That any City of Barrie fees associated with the Patios Everywhere Program and the Downtown BIA Patio Program be waived for the 2021 patio season from April 1, 2021 to November 30, 2021.
- 7. That the Director of Development Services or their designate be given delegated authority to issue permits under the Patios Everywhere Program to Refreshment Vehicles, including determining the application process, operating criteria and to work with other operational departments to establish designated spots for these vehicles. (ECD002-21) (P42/20)

21-G-062 MARKET PRECINCT TASK FORCE, PERFORMING ARTS CENTRE TASK FORCE, AFFORDABLE HOUSING TASK FORCE

WHEREAS revitalizing the west end of Downtown Barrie and the creation of more affordable housing are urgent priorities for Council; and

WHEREAS the recent decision to close Georgian Theatre and not to proceed with renovating Fisher Auditorium has highlighted the urgent need for a large performing arts facility in Barrie; and

WHEREAS helping the City's residents, business community, and cultural community recover from COVID includes addressing these three key issues, which can be part of a strong recovery for Barrie; and

WHEREAS Council directed City staff to develop a funding strategy by April for strategic projects, as part of the 2021 Business Plan;

THEREFORE BE IT RESOLVED as follows:

- 1. That three Task Forces; a Market Precinct Task Force, a Performing Arts Centre Task Force, and an Affordable Housing Task Force be established.
- 2. That each Task Force be mandated to report to General Committee by the end of 2021 with a plan to accomplish the following:
 - a) Market Precinct Task Force a plan for investments in the economy and in public spaces in the west end of Downtown Barrie;
 - b) Performing Arts Centre Task Force a plan to construct a modern performing arts facility in the city core to replace Georgian Theater and Fisher Auditorium; and
 - c) Affordable Housing Task Force a plan to co-ordinate County, City, and charitable/not-for-profit housing projects and policies, to aggressively expand the supply of affordable housing, with particular emphasis on addressing the hardest to house.
- 3. That each Task Force be comprised of interested members of Council, stakeholder organizations from the downtown, cultural, and housing communities as identified by the Chairs, and staff as identified by the Chief Administrative Officer and/or the Executive Management Team.

- 4. That the Market Precinct Task Force be chaired by Deputy Mayor, B. Ward, the Performing Arts Centre Task Force be chaired by Councillor, J. Harris, and the Affordable Housing Task Force be chaired by Mayor, J. Lehman.
- 5. That the Mayor's Office provide administrative (minutes, scheduling) support to the Task Forces, and technical support (mapping, feasibility expertise, etc.) be provided by the following Departments:
 - a) Market Precinct Task Force Development Services;
 - b) Performing Arts Centre Task Force Recreation and Culture Services and Economic and Creative Development; and
 - c) Affordable Housing Task Force Development Services.
- 6. That each Task Force provide updates via memorandum to Council in June, 2021 and September, 2021.
- 7. That each Task Force identify any funding requirements associated with their activities, which will be submitted to General Committee as part of the June update, and funded from the Council Strategic Priorities Account if less than \$20,000 for the year.
- 8. That each Task Force develop an open public consultation portal (online and by phone) and provide for any additional specific public consultation opportunities as deemed appropriate.
- 9. That given potential Federal and Provincial funding programs may be available in support of COVID recovery, City staff be delegated authority to apply for grants generally in line with the objectives of the Task Force, with funding agreements to be subject to Council approval prior to execution if a grant application is successful. (Item for Discussion 8.1, March 8, 2021)
