The purpose of this Memorandum is to provide members of Council with a copy of the recommended key performance indicators (KPIs) that the Executive Management team has developed to measure Council's strategic priorities for the 2022-2026 term of office.

On Saturday December 3, 2022 the newly elected Council met to establish the key strategic priorities and direction for the term of office. At the session, Council identified five goals that will guide the strategic direction for the City over the next four years. Staff were then directed to develop KPIs for measuring the success of the plan. Three to five KPIs were chosen for each priority as they were felt to be the most meaningful and measurable indicators aligned with Council's strategic role and responsibility. Providing too many measurements can be very resource intensive. In addition, at the operational level departments measure additional KPIs but these Council Priority KPIs allow for the strategic lens to be applied to the progress of Council's priority areas.

The five priorities for the 2022-2026 Council and recommended KPIs are as follows:

<b>Thriving Community</b>	<ul style="list-style-type: none"> <li>• Average Household income</li> <li>• RecACCESS participation rate as a percentage of low-income population</li> <li>• Economic Impact of Hotel Stays- Tourism Barrie</li> <li>• Number of Participants in City Recreation and Culture programs</li> </ul>

<b>Infrastructure Investments</b>	<ul style="list-style-type: none"><li>• Annual Transit Ridership</li><li>• Average Pavement Condition Index for the City's Road Network</li><li>• Number of potholes fixed</li><li>• % of core City assets (Roads, Water, Wastewater, Facilities, stormwater) with a condition assessment rating of fair or better condition</li></ul>
