ORIENTATION FOR THE COMMITTEE

Mr. Forsyth and Ms. Miller discussed slides concerning the following topics:

- The Current Free Day of Transit for seniors;
- A pie chart illustrating the conventional senior ridership in 2021-2022;
- A summary of the City's monthly Recreation and Community Centre Programs for seniors;
- The days of the week that various retailers and businesses offer senior discounts; and
- City staff seeking consensus on the preferred second day for free transit for seniors.

Mr. Forsyth and Ms. Miller opened the discussion by seeking input from Committee members seeking concerning the additional day of free transit for seniors per week.
