



<u>COVID-19</u>: The Most Severe Pandemic in a Century




- Ontario: some 1.62 million cases and over 16,500 deaths to date
- <u>Simcoe Muskoka</u>: over 58,000 cases and over 765 deaths reported to date
- More deaths occurred in 2022 than in 2020 and 2021 combined
 - In 2023 continued to have between 2 to 11 deaths per week in Simcoe Muskoka until recently
 - Lower to Moderate Risk in Simcoe Muskoka since May 4th



SMDHU Pandemic Response Roles

- Surveillance
- COVID-19 case and contact management, and outbreak response
- Vaccination over 80% of the population of Simcoe Muskoka, with over 1.55 million doses administered (SMDHU, pharmacies, RVH, OSMH, LTC, EMS, municipalities, primary care, health care providers)
- Public Health Measures communication, education and enforcement of health directives through the course of the pandemic
- Communication public / media / social media messaging
- Partner engagement health care agencies, Ontario Health Central Region, Ontario Health Teams, municipalities (CAOs), MPPs, equity deserving populations and other groups / venues
- Priority public health programs and services






