

COMMITTEE OF ADJUSTMENT PUBLIC NOTICE OF HEARING SUBMISSION NO. A9/23

TAKE NOTICE that an application has been received from **Ouellet and Associates Design Inc. c/o Sean Ouellet on behalf of 4396031 Canada Inc.** for a minor variance from Zoning By-law 2009-141, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

IN THE MATTER OF the premises described as PLAN 27 E PT LOT 14 and known municipally as **223 Dunlop Street West** in the City of Barrie.

This property is zoned Residential Multiple Dwelling Second Density with Special Provision No. 189 (RM2)(SP-189).

This application, if granted by the Committee of Adjustment, will serve to permit a reduction in the drive aisle width and landscape buffer width to facilitate the change of use from a single detached dwelling to a tri-plex. The property is subject to Site Plan Exemption Application D11-EXE-047-2022.

The applicant is seeking the following minor variance(s):

- 1. A drive aisle width of 3.4 metres, whereas the Comprehensive Zoning By-law 2009-141, under Section 4.6.2.5, requires a minimum aisle width of 6.4 metres.
- 2. A landscape buffer width of 0.0 metres, whereas the Comprehensive Zoning By-law, under subsection 5.3.7.1 requires a minimum width of 3 metres.

TAKE FURTHER NOTICE that the Committee of Adjustment public hearing has been scheduled for **Tuesday, June 20, 2023.** This public meeting will be held in a virtual forum with electronic participation. The application and others will be heard commencing at **5:00 p.m. via ZOOM.**

Notices are sent to all property owners shown on the last assessment records within 60m of the subject property.

Although this is a public hearing, you are not required to attend unless you wish to speak to the application. If you have specific comments regarding this application, you may submit comments to the Secretary-Treasurer of the Committee of Adjustment at <u>cofa@barrie.ca</u>.

Every attempt should be made to file your submission six days prior to the Public Hearing date. Notice of the decision will be provided to each person who appeared in person or by authorized representative at the hearing and who files with the Secretary-Treasurer a written request for notice of the decision. If you do not attend, the hearing will proceed in your absence, and you will receive no further notice. You must register and attend the hearing to receive further notice.
