



**BY-LAW NUMBER 2024 -**

**A By-law of The Corporation of the City of Barrie to exempt all of Block 153 on Plan 51M-1228, designated as Parts 7 to 12 (inclusive) on Plan 51R-44422, City of Barrie, County of Simcoe; being all of PINs: 58727-1243 (LT) from Part Lot Control imposed by Section 50(5) of the *Planning Act*, R.S.O. 1990, c.P.13.**

**WHEREAS** Section 50, Subsection 7 of the *Planning Act*, R.S.O. 1990, c.P.13 provides that, notwithstanding the provisions of Subsection 5, the Council of a municipality may by by-law provide that plans of subdivision or parts of them are designated in the by-law are not subject to Subsection 5 of Section 50;

**AND WHEREAS** R-PE Surveying Ltd. on behalf of the owner GG (9 Mile) Limited has applied to the Council of The Corporation of the City of Barrie requesting that a by-law be enacted under the provisions of Subsection 7 of Section 50 of the *Planning Act*, R.S.O. 1990, c.P.13;

**AND WHEREAS** the Council of The Corporation of the City of Barrie adopted Motion 12-G-190;

**AND WHEREAS** the Council of The Corporation of the City of Barrie deems it expedient to pass a by-law pursuant to the provisions of Subsection 7 of Section 50 of the *Planning Act*, R.S.O. 1990, c.P.13 to exempt all of Block 153 on Plan 51M-1228, designated as Parts 7 to 12 (inclusive) on Plan 51R-44422, City of Barrie, County of Simcoe; being all of PIN: 58727-1243 (LT).

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

1. **THAT** Subsection 5 of Section 50 of the *Planning Act*, R.S.O. 1990, c.P.13 does not apply to exempt all of Block 153 on Plan 51M-1228, designated as Parts 7 to 12 (inclusive) on Plan 51R-44422, City of Barrie, County of Simcoe; being all of PIN: 58727-1243 (LT).
2. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 31<sup>st</sup> day of January, 2024.

**READ** a third time and finally passed this 31<sup>st</sup> day of January, 2024.
