**BY-LAW NUMBER 2011-**

**A By-law of The Corporation of the City of Barrie  
to amend By-law 2006-266 being a by-law to  
license, regulate and govern businesses carried  
on within the Municipality.**

**WHEREAS** Section 8 of the *Municipal Act* 2001, S.O. 2001, c. 25 ("the *Municipal Act*, 2001"), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

**AND WHEREAS** Section 9 of the *Municipal Act*, 2001, provides that Sections 8 and 11 shall be interpreted broadly so as to confer broad authority on municipalities to (a) enable municipalities to govern their affairs as they consider appropriate and, (b) enhance their ability to respond to municipal issues;

**AND WHEREAS** Section 11 of the *Municipal Act*, 2001, provides that a single-tier municipality may pass by-laws respecting matters within the spheres of jurisdiction set out therein;

**AND WHEREAS** the Council of The Corporation of the City of Barrie passed By-Law Number 2006-266, on October 30, 2006 with an effective date of January 1, 2007;

**AND WHEREAS** pursuant to motion 11-G-109, the Council of The Corporation of the City of Barrie deems it expedient to amend By-Law Number 2006-266;

**NOW THEREFORE**, the Council of The Corporation of the City of Barrie enacts as follows:

1. **THAT** By-law 2006-266, Table 1 – Business Licence Fees for the licensing categories be deleted and replaced with the Schedule "A" attached hereto to facilitate the amendments to the licensing category identified as Restaurant/Tavern, Restaurant/Tavern Patio Extension – Private Property, Restaurant/Tavern Patio Extension – Municipal Property.
2. **THAT** By-law 2006-266, Section 81.2.0.0 Operating Criteria – Restaurant/Tavern be amended by adding the following:

"81.2.28.0.0      "The applicant shall provide to the Issuer of Licences at the time of application, a completed City of Barrie liquor licence application questionnaire".
3. **THAT** By-law 2006-266, Section 83.2.0.0 Operating Criteria – Restaurant/Tavern – Outdoor Patio Extension – Private Property be amended by adding the following:

"83.2.12.0.0      "The applicant shall provide to the Issuer of Licences at the time of application, a completed City of Barrie liquor licence application questionnaire".
4. **THAT** By-law 2006-266, Section 84.2.0.0 Operating Criteria – Restaurant/Tavern – Outdoor Patio Extension – Municipal Property be amended by adding the following:

"84.2.15.0.0      "The applicant shall provide to the Issuer of Licences at the time of application, a completed City of Barrie liquor licence application questionnaire".
3. **THAT** this By-law shall come into force and effect upon the day of passing thereof.

**READ** a first and second time this 9<sup>th</sup> day of May 2011.

**READ** a third time and finally passed this 9<sup>th</sup> day of May 2011.
