BY-LAW NUMBER 2011-

A By-law of The Corporation of the City of Barrie to amend By-law 2011-049 being a by-law with respect to the establishment and requirement of the payment of fees for information, services, activities and use of City property and to repeal By-laws 2010-040 and 2010-041.

WHEREAS the Council of The Corporation of the City of Barrie may pass by-laws establishing and requiring the payment of fees for information, services, activities and use of City property;

AND WHEREAS Section 391 of the Municipal Act 2001, S.O. 2001, as amended, provides for a municipality to pass by-laws imposing fees or charges on persons for services and activities provided or done by or on behalf of it, for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board, and for the use of its property including property under its control;

AND WHEREAS Section 69 (1) of the Planning Act R.S.O. 1990, c. P. 13, as amended, provides that a municipality may establish a tariff of fees for the processing of applications;

AND WHEREAS Section 7 of the Building Code Act, 1992, S.O. 1992, as amended, authorizes a municipal Council to pass by-laws concerning the issuance of permits and related matters requiring the payment of fees on applications for and on the issuance of permits;

AND WHEREAS the Council of the City of Barrie enacted By-law 2011-049 being a by-law with respect to the establishment and requirement of the payment of fees for information, services, activities and use of City property;

AND WHEREAS the Council of The Corporation of the City of Barrie deems it necessary to repeal By-law 2010-040 being a by-law to impose 2010 wastewater rates and to prescribe the amount of such rates on the 22nd day of February 2010;

AND WHEREAS the Council of The Corporation of the City of Barrie deems it necessary to repeal By-law 2010-041 being a by-law to impose 2010 water rates and to prescribe the amount of such rates on the 22nd day of February 2010;

AND WHEREAS by motion 11-G-072 as amended by 11-A-124 Council deems it expedient to enact a by-law to impose 2011 water and wastewater rates and to prescribe the amount of such water and wastewater rates for 2011;

NOW THEREFORE, the Council of The Corporation of the City of Barrie hereby enacts as follows:

- **1. THAT** By-law Number 2011-049 be amended by adding "Section 7, Water and Wastewater Rates, Schedule "J", Operations Department", attached hereto and forming part of this by-law.
- **2. THAT** By-laws 2010-040 and 2010-041 be and are hereby repealed.
- **3. THAT** this By-law shall come into force and effect May 1, 2011.

READ a first and second time this 30th day of May, 2011.

READ a third time and finally passed this 30th day of May 2011.
