**A By-law of The Corporation of the City of Barrie
to amend By-law 2011-020 a by-law to appoint
members to various committees, boards and
commissions**

WHEREAS, the Council of The Corporation of the City of Barrie may appoint representatives to various committees, boards and commissions;

AND WHEREAS, the Council of The Corporation of the City of Barrie enacted By-law 2011-020 to appoint members to various committees, boards and commissions;

AND WHEREAS, pursuant to motion 12-G-199, the Council of the Corporation of the City of Barrie deems it expedient to amend By-law 2011-020 with respect to the appointment of members to various committees, boards and commissions.

NOW THEREFORE, the Council of The Corporation of the City of Barrie hereby enacts as follows:

1. **THAT** By-law 2011-020 be amended by deleting Schedule "A" and replacing it with Schedule "A" attached hereto and forming part of this by-law.
2. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.
