**BY-LAW NUMBER 2012-**

**A By-law of The Corporation of the City of Barrie to establish Part of Lot 259, Plan 51M-623, designated as Part 3, Plan 51R-28147 and Part 3, Plan 51R-30883, Part of Lot 260, Plan 51M-623, designated as Part 2, Plan 51R-28147 and Part 2, Plan 51R-30883, Part of Lot 261, Plan 51M-623, designated as Part 1, Plan 51R-28147, Block 301, Plan 51M-623, Part of Block 290, Plan 51M-623, designated as Part 4, Plan 51R-30883, Part of Lot 283, Plan 51M-623, designated as Part 6, Plan 51R-30883, Block 39, Plan 51M-842, City of Barrie, County of Simcoe as part of the municipal highway system.**

**WHEREAS** Section 10 of the *Municipal Act*, 2001, S.O. 2001, c. 25 as amended (the "Municipal Act"), provides that a single-tier municipality may pass by-laws respecting matters set out therein including, inter alia, public assets of the municipality acquired for the purpose of exercising its authority under the Municipal Act or any other Act;

**AND WHEREAS** the establishing and naming are approved in accordance with Registered Plans 51M-623 and 51M-842;

**AND WHEREAS** the Council of The Corporation of the City of Barrie deems it expedient to establish Part of Lot 259, Plan 51M-623, designated as Part 3, Plan 51R-28147 and Part 3, Plan 51R-30883, Part of Lot 260, Plan 51M-623, designated as Part 2, Plan 51R-28147 and Part 2, Plan 51R-30883, Part of Lot 261, Plan 51M-623, designated as Part 1, Plan 51R-28147, Block 301, Plan 51M-623, Part of Block 290, Plan 51M-623, designated as Part 4, Plan 51R-30883, Part of Lot 283, Plan 51M-623, designated as Part 6, Plan 51R-30883, Block 39, Plan 51M-842, City of Barrie, County of Simcoe as part of the municipal highway system.

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

1. **THAT** Part of Lot 259, Plan 51M-623, designated as Part 3, Plan 51R-28147 and Part 3, Plan 51R-30883, Part of Lot 260, Plan 51M-623, designated as Part 2, Plan 51R-28147 and Part 2, Plan 51R-30883, Part of Lot 261, Plan 51M-623, designated as Part 1, Plan 51R-28147, Block 301, Plan 51M-623, Part of Block 290, Plan 51M-623, designated as Part 4, Plan 51R-30883, Part of Lot 283, Plan 51M-623, designated as Part 6, Plan 51R-30883, Block 39, Plan 51M-842, City of Barrie, County of Simcoe be established as part of the municipal highway system and be named Osprey Ridge Road.
2. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 22<sup>nd</sup> day of October, 2012.

**READ** a third time and finally passed this 22<sup>nd</sup> day of October, 2012.
