

BY-LAW NUMBER 2012 -

A By-law of The Corporation of the City of Barrie to appoint Municipal Law Enforcement Officers as authorized under the provision of the Police Services Act.

WHEREAS, pursuant to the Police Services Act, R.S.O. 1990, c. P.15, as amended, the Council of any municipality may appoint Municipal Law Enforcement Officers who shall be Peace Officers for the purpose of enforcing the by-laws of the municipality;

AND WHEREAS Section 8 of the Municipal Act, 2001, S.O. 2001, c.M.25 ("the Municipal Act, 2001"), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

AND WHEREAS Section 9 of the Municipal Act, 2001, provides that Sections 8 and 11 shall be interpreted broadly so as to confer broad authority on municipalities to (a) enable municipalities to govern their affairs as they consider appropriate and, (b) enhance their ability to respond to municipal issues;

AND WHEREAS Section 11 of the Municipal Act, 2001, provides that a single-tier municipality may pass by-laws respecting matters within the spheres of jurisdiction set out therein;

AND WHEREAS, pursuant to Section 227, of the Municipal Act, 2001, it is the role of the officers and employees of the municipality to implement council's decisions and establish administrative practices and procedures to carry out council's decisions; to undertake research and provide advise to council on the policies and programs of the municipality and to carry out other duties as required under this or any Act and other duties assigned by the municipality;

NOW THEREFORE the Council of The Corporation of the City of Barrie enacts as follows:

- 1. **THAT** Aaron Isaac Speers be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of his employment as a Municipal Law Enforcement Officer.
- 2. **THAT** Tae-Wung Choi be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of his employment as a Municipal Law Enforcement Officer.
- 3. **THAT** Sean David Paul Doig be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of his employment as a Municipal Law Enforcement Officer.
- 4. **THAT** Vincenzo Raponi be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of his employment as a Municipal Law Enforcement Officer.
- 5. **THAT** Ilia Vladamir Gouchtine be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of his employment as a Municipal Law Enforcement Officer.
- 6. **THAT** Raymond Francis Alberto White be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of his employment as a Municipal Law Enforcement Officer.
- 7. **THAT** this by-law shall come into force and effect immediately upon the passing thereof.
