**Subject:** Attention City Clerk -Deputation to oppose motion - on street parking Big Bay Pt Rd

Honourable Mayor and Members of Council, I wish to make a deputation to City Council in opposition to motion 17G 040.

February 2016 a petition was filed to keep on street parking, with 30 signatures from residents of Big Bay Pt Rd from Loon to Pine north and south sides and a list of concerns.

The staff report suggests 28 of 29 homes on south side only ,Loon to Ashford were ok with no on street parking. 13 of those same 29 homes are listed on the petition to keep on street parking. Of those same 29 homes 3 owners were not home . I was one of them. It is not understood how there can be such markedly different results.

The staff report doesn't list all our concerns and paraphrases some. None of the issues and concerns have really been addressed. Our driveways were shortened and there was a grade change with the road widening.

Where is company supposed to park? Where does one load the trailer for vacation? Where would maintenance vehicles park in case of house or tree maintenance? Where would we park in winter because we can't get into the driveway because the snow plough has filled it with 3 lanes of snow? How do we get safely in and out of the driveway when traffic is speeding? Honks their horn or uses rude gestures? It doesn't seem our issues and concerns have been addressed. Respectfully,
