RECOMMENDED MOTION

1. That the list of proposed names for the Municipal Names Registry, as identified in Appendix "A" to Staff Report PLN007-19, be approved.

PURPOSE & BACKGROUND

Report Overview

- 2. The purpose of this report is to recommend a list of names to repopulate the Municipal Names Registry list that will be used to facilitate the naming of streets, parks and other municipal assets in future developments within the City.
- 3. Council approved the Municipal Street Naming policy on January 11, 2016, which established the processes and criteria for naming, renaming or dedicating municipal assets such as streets, parks, and facilities as well as the major elements of such municipal assets, including the methods by which the public may provide suggestions and comments.
- 4. The Municipal Names Registry is a central repository of all approved names for streets, parks, and other municipal assets. The registry includes qualifying names as suggested by the public, and commemorative names.
- 5. The current list of Council approved names on the Municipal Names Registry has been depleted and repopulation of the list is required.

ANALYSIS

Process for Assigning Street Names without a Municipal Names Registry:

- 6. The current process for municipal naming approvals is done on an individual basis, as per the Municipal Naming Policy (January 2016). Planning staff review requests individually from the proponent or developer for municipal names to ensure a complete explanation of the significance of the name is provided.
- 7. Planning staff circulate all names submitted to appropriate City departments and external stakeholders, including Emergency Services for commenting.
- 8. Planning staff inform the developer if the name is deemed unacceptable. If the proposed name(s) are deemed unacceptable, the developer is required to provide additional names and return to the circulation process again until approval is provided from City departments and external stakeholders.
- 9. Planning staff prepare a report for General Committee's consideration with respect to proposed naming of municipal assets. Final approval is granted by Council. Once the municipal names are approved, the Planning Department is able to proceed with assigning municipal addresses within the development.

Circulation and Vetting Process Comments:

- 10. A complete list of proposed names for the Municipal Names Registry were circulated to appropriate City departments and external stakeholders, including neighbouring municipalities. No concerns have been raised regarding the proposed names found on Appendix "A".
- 11. Names shown on Appendix "C" are names that were recommended but did not meet the criteria outlined below and cannot be put forward for approval.


Street Suffix Assignment:

- 12. All of the proposed names, to be used for streets are to be followed by the Council approved suffix of Street, Drive, Avenue, Boulevard, Crescent, Court, Gate, Lane, Trail, Way, Terrace, Garden, Grove, Pathway, Heights, Land and Mews.
- 13. The suffix will be assigned by the Planning Department at the time that the proposed street names are selected by the developer, based on the Council approved street name type designations, indicated in Appendix "B" of the Municipal Naming Policy.
- 14. Private Roads shall receive the suffix "Lane" as per the Council approved Private Road Naming Policy.

Naming Principles and Guidelines:

- 15. The proposed names have met the criteria of the following Naming Principles set out in the Council approved Municipal Naming Policy:
 - a) The names are unique and avoid name duplication in the City of Barrie and surrounding municipalities.

- b) The names give a sense of place, continuity, and belonging and celebrate the distinguishing characteristics and uniqueness of Barrie.
- c) The names maintain a long standing local area identification with the residents of Barrie.
- d) The names promote pride in the City of Barrie and acknowledge local heritage, history and unique features.
- e) The proposed names reflect the geography, wildlife, flora, and natural features within the City of Barrie.
- 16. In accordance with the Municipal Naming Policy, the proposed names meet and reflect the criteria of the Naming Principles in the following ways:

Proposed Names Reflecting Canadian Geography:

- a) Aurora: Named after the Aurora Borealis, known for being Canada's most notorious natural feature that can be viewed all across the country.
- b) Banff. Named after a town located in the Canadian Rocky Mountains and is along the Trans-Canada Highway.
- c) Breton: Named after Cape Breton in Canada, which derives from the Basque Cap Breton, a location near Bayonne France.
- d) Fundy: Named after the Bay of Fundy in Canada, known for the world's highest tides.
- e) Great Lakes: These lakes make up the largest body of fresh water on earth.
- f) Jasper. Named after the centre of Jasper National Park, located in the Canadian Rockies.
- g) Laurentian: Named after the Laurentian Shield or Laurentian Plateau.
- h) Northwest: Named after the Northwest Territories of Canada.
- Okanagan: Named after the Okanagan Valley in south-central British Columbia and is originally home to the Okanagan First Nations. The area is one of the largest producers of fruit and wine in Canada.
- j) *Tofino*: Named after the famous district off of Canada's west coast and is characterized by wild natural scenery.
- k) Yellowknife: Named after the capital city of Canada's Northwest Territories.

Proposed Names Reflecting the Geography and Natural Features of Simcoe County and Ontario:

a) Beckwith: Named after Beckwith Island in Georgian Bay, which is the eastern of three islands in southeastern Georgian Bay in Ontario.

- b) Christian: Named after Christian Island in Georgian Bay, which is the largest island in Georgian Bay.
- c) Garnet: Named after Garnet Island in Lake Simcoe.
- d) Grape: Named after Grape Island in Lake Simcoe.
- e) Hope: Named after Hope Island in Georgian Bay, which is the northern of three islands in southeastern Georgian Bay.
- f) Mara: Named after Mara Point in Lake Simcoe.
- g) Strawberry: Named after Strawberry Island in Lake Simcoe.
- h) Thistle: Named after Thistle Island in Lake Simcoe.
- i) Thorah: Named after Thorah Island in Lake Simcoe.
- j) Burleigh: Named after Burleigh Falls, a geological feature that is connected to the Trent-Severn Waterway.
- k) Cache: Named after a freshwater lake located in Algonquin Park.
- I) Chapleau: Named after the lake that is home to one of the world's largest wildlife preserves and is known for its logging mill in Ontario.
- m) Clear Lake: Named after a freshwater lake located in Algonquin Park.
- n) Little Hawk: Named after a freshwater lake located in Algonquin Park.
- o) *Matchedash*: Named after a lake and cottage country area located in Simcoe Country, attached to the Trent-Severn Waterway.
- p) *Mattawa*: Named after the waterbody that was first passed through by Samuel de Champlain.
- q) *Mordolphin*: Named after an area and small water body located in Simcoe Country, attached to the Trent-Severn Waterway.
- r) Otter: Named after a lake located in Simcoe County, attached to the Trent-Severn Waterway.
- s) *Pinecone*: Named after the natural feature that comes from a variety of Canadian tree species such as the pine tree, spruce tree, cedar tree and hemlock trees.
- t) Rosseau: Named after a well-known popular lake located in Muskoka.
- u) White Partridge: Named after a freshwater lake located in Algonquin Park.

Proposed Names after Barrie Geography:

- a) Beachcove: Represents Barrie's waterfront community of beaches.
- b) *Blue Anchor*: Represents Barrie's waterfront community and the popular J.C. Morrison shipwreck located along our shoreline.
- c) Bluestem: Named after a flower species that is frequently found in Barrie and Simcoe Region.
- d) Daisy: Named after a common flower species that can be found in Ontario.
- e) *Mallard*: Named after a common bird species that frequents Barrie and the rest of Ontario.
- f) Magnolia: Named after a common flower species found in Ontario.
- g) Northgate: Barrie is the gateway to northern cottage country.
- h) Red Maple: Common tree species that is found in Simcoe County.
- i) Underhill: Named after the Underhill family which owned the Underhill Shoe Factory in Barrie. An application has been brought forward to the City that has supporting documentation and history of the Underhill family and is attached as Appendix "B" in this document.
- j) Yachtsman: Named after Barrie's harbour front community and reflects the vast amount of marine activity and boat launches located around Kempenfelt Bay.

- a) Averill: Named after Lieutenant Frederick Averill Hall (World War 1)
- b) Beckett: Named after Private William Henry Beckett (World War 1)
- c) Desourdie: Named after Private Joseph Desourdie (World War 1)
- d) Douse: Named after John Harrison Douse (World War 2)
- e) Gilbank: Named after Ernest Nelson Gilbank (World War 2)
- f) Hiltz: Named after A. Leo Hiltz (World War 2)
- g) Lowe: Named after Edward Ronald Lowe (Korean War)
- h) MacNamara: Named after Captain William James MacNamara (World War 1)
- i) Magrane: Named after Private George Vincent Magrane (World War 1)

- n) Roe: Named after Alexander R. Roe (World War 2)

Proposed Names after Historic Canadians:

- a) Adamson: Named after General Sir Peter Adamson who was awarded seven gold medals for bravery and distinguished services, and the Order of the Knight of Tower and Sword which is the highest honor in Portugal for his heroic actions at the Battle of Salamanca in 1813. When he came to Canada in 1817, he was granted in excess of 2000 acres of land in Peel and Halton areas, in recognition for his considerable military services and rank. He was the first to be authorized to raise the First Provisional Battalion of Incorporated Militia of Upper Canada.
- b) Dallaire: Named after Romeo Dallaire, a Canadian army officer who led the ill-fated United Nations peacekeeping mission in Rwanda.
- c) Gladestone: Named after James Gladestone, who was a Canadian politician who became the first status Indian to be appointed to the Senate of Canada.
- d) Gretzky: Named after Wayne Douglas Gretzky and is a notable Canadian hockey player known for his hockey world records.
- e) Hadfield: Named after Colonel Chris Hadfield who was the first Canadian astronaut to live aboard the International Space Station.
- f) Pearson: Named after Lester Boweles Pearson, whom is known for his work as a diplomat of the 1950s and 1960s and formulated its basic post World War 2 foreign policy. He received the Nobel Peace Prize for his diplomatic efforts in facilitating Britain's and France's departure from Egypt during the Suez Crisis.
- g) Secord: Named after Laura Secord (no relation to the chocolate company), who is considered a Canadian Heroine of the War of 1812, known for having walked 32 km out of American-occupied territory in 1813 to warn British forces of an impending American attack.
- h) Suzuki: Named after David Takayoshi Suzuki, a Canadian of Japanese parentage who is an award-winning scientist, environmentalist and broadcaster.

- The Underhill family has been associated with Barrie for over a century.
- Six generations of the family have lived in Barrie, four generations currently reside in the city;
- From 1913 to 1956, the family (father Fred Underhill, sons Stan, Ross and Blake Underhill) owned and operated Underhill's Shoe Factory in Barrie;
- It was a major employer in the city, with a workforce of 100 at a time when the population of Barrie was under 10,000. Of note, 25% of the work force in the 1920s was female;
- Of note, all the leather used in the factor came from the Barrie Tannery (supporting other local businesses), the shoes were made start to finish at the factory and the boxes/packaging were also made done in the factory;
- Underhill shoes and boats were sold Canada-wide (advertising Barrie), major clients included
 T.E. Eaton Company and the Canadian Military;
- The factory also sponsored a local hockey team (Underhill Hornets, Town League) during the 1920s and 1930s;
- Blake Underhill was in the Royal Air Force during World War 1 (he was not overseas because he
 was still in pilot training when the war ended). During the Second World War, he was in the
 RCAF, serving as a staff officer in Ottawa, with the rank of Squadron Leader. Following the war,
 he was active in the Air Force reserve as a Squadrom Leader;
- Blake Underhill was a member of the Barrie Rotary Club and served as president in the late 1940s. He was also a member of the Barrie Curling Club and served as president in 1947;
- Bryan Underhill was a practicing Chartered Accountant in Barrie for over 30 years, first as a
 resident partner with Harris, Needham & Wright, then a senior partner with Needham & Underhill.
 He was a partner and tax specialist with Clarkson-Gordon following a merger with that firm in the
 early 1980s, and a partner and tax specialist with Ernst-Young following a subsequent merger
 later in the 1980s. In all of its iterations, the firm served many clients in Barrie and Simcoe
 County, as well as Muskoka and Nipissing Districts.
