**BY-LAW NUMBER 2019-**

**A By-law of The Corporation of the City of Barrie to amend By-law 89-86 being a by-law to designate private roadways as Emergency Fire Routes along which no parking of vehicles shall be permitted.**

**WHEREAS**, pursuant to the *Fire and Protection Act, 1997*, S.O. 1997, C.4, s.7.1.(1)(c) the Council of any municipality may designate private roadways as emergency fire routes along which no parking of vehicles shall be permitted;

**AND WHEREAS**, the Council of The Corporation of the City of Barrie adopted By-law 89-86 being a by-law to designate private roadways as emergency fire routes along which no parking of vehicles shall be permitted;

**AND WHEREAS**, by motion 05-G-514, it is deemed expedient that the Council of The Corporation of the City of Barrie amend By-law 89-86, as amended, being a by-law to designate private roadways as emergency fire routes along which no parking of vehicles shall be permitted.

**AND WHEREAS** Section 8 of the *Municipal Act, 2001*, provides that the power of a municipality shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as they consider appropriate and to enhance the municipality's ability to respond to municipal issues.

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts as follows:

1. **THAT** By-law 89-86 be amended by adding Schedule 268 attached hereto as Schedule "A" designating an emergency fire route at 369 Essa Road (SCECC 418).
2. **THAT** By-law 89-86 be amended by adding Schedule 269 attached hereto as Schedule "B" designating an emergency fire route at 1 Leggott Avenue (SCECC 443).
3. **THAT** By-law 89-86 be amended by deleting Schedule 9 and replacing it with Schedule "C" attached hereto designating an emergency fire route at 165 Wellington Street West (Barrie Plaza La Limited).
4. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 17th day of June, 2019.

**READ** a third time and finally passed this 17th day of June, 2019.

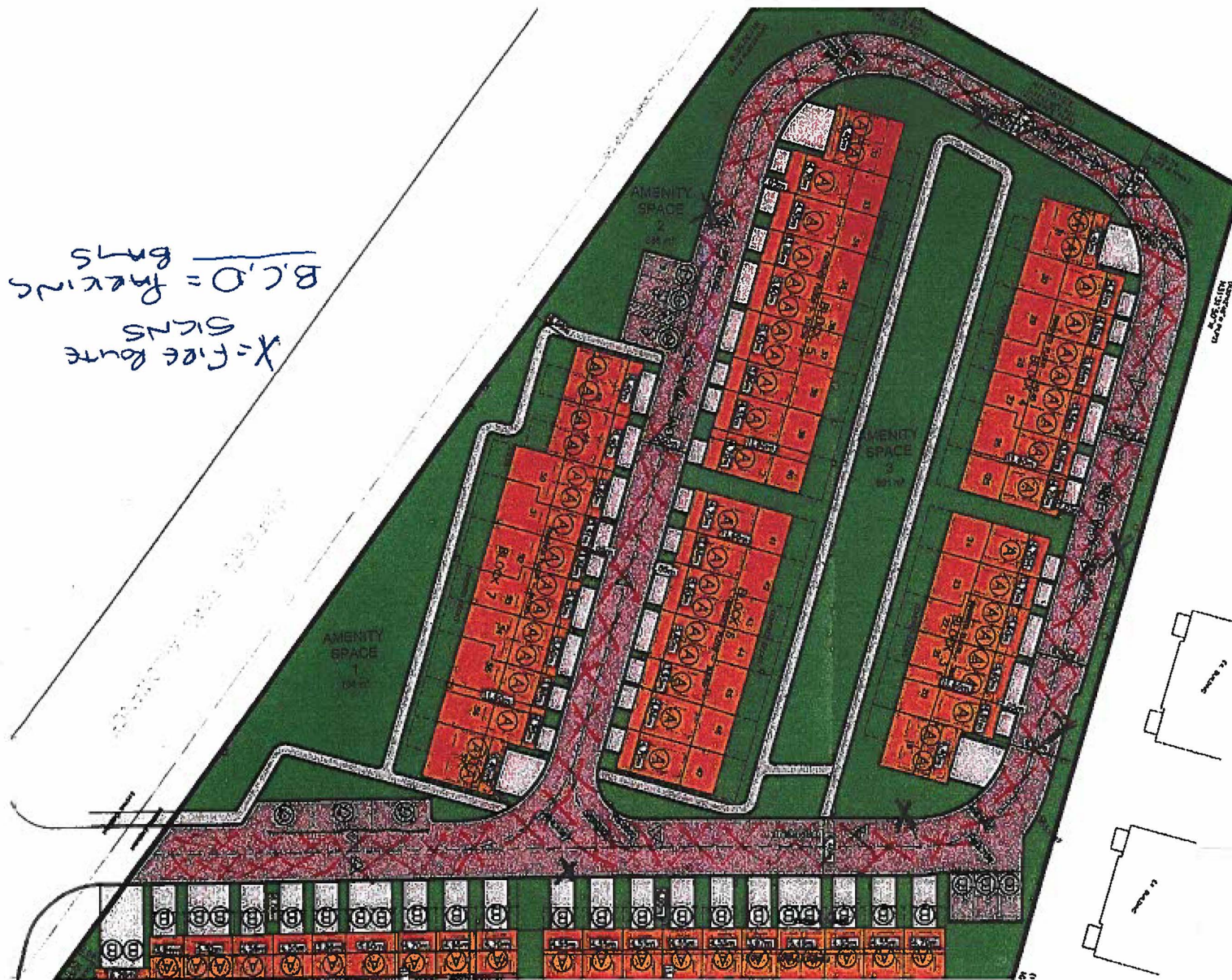

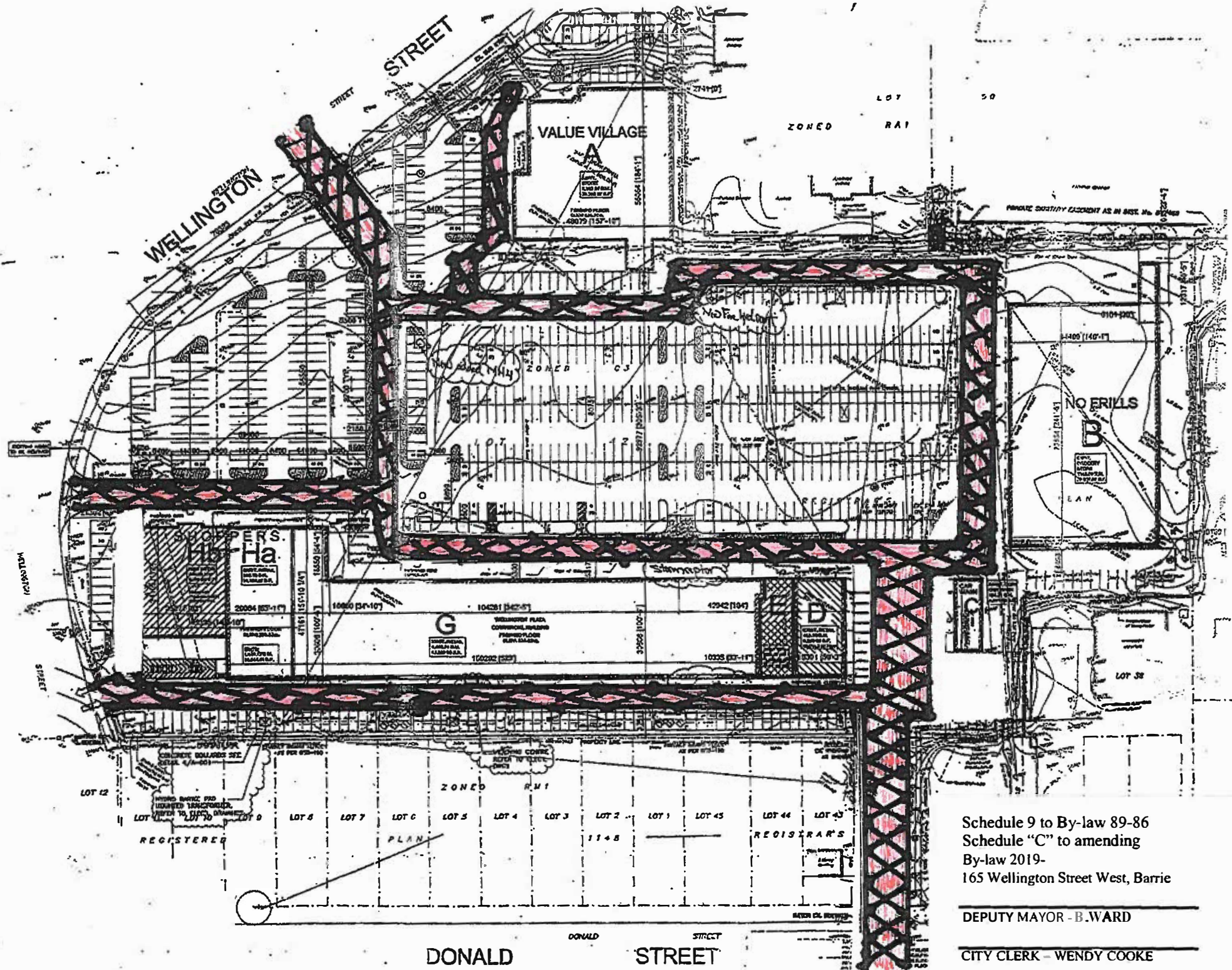
