PURPOSE & BACKGROUND

CHURCHLAND DRIVE

- 7. Staff in the Roads, Parks and Fleet Department received concerns from area residents regarding the implementation of a Community Safety Zone and reduced 40 km/h speed limit along Churchland Drive to incorporate the pedestrian walkway which provides a direct connection to St. Bernadette Elementary School. Please refer to Appendix "A".
- 8. Currently, there is not a Community Safety Zone or reduced 40 km/h speed limit along Churchland Drive for St. Bernadette Elementary School. The current Community Safety Zone and reduced 40 km/h speed limit for St. Bernadette Elementary School is located on Marsellus Drive, which extends from Downing Crescent to Farmstead Crescent.

SANDRINGHAM DRIVE

- 9. Staff in the Roads, Parks and Fleet Department received concerns from area residents regarding the extension of the current Community Safety Zone and reduced 40 km/h speed limit along Sandringham Drive to incorporate the pedestrian walkway located at Sandringham Drive and Consort Drive which provides a direct connection to Hewitt's Creek Elementary School. Please refer to Appendix "B".
- 10. The current limits of the Community Safety Zone and reduced 40 km/h speed limit for Sandringham Drive is from Big Bay Point Road to a point 135 metres north of Consort Drive.

ANALYSIS

CHURCHLAND DRIVE

11. Staff reviewed the pedestrian walkway along Churchland Drive and determined a Community Safety Zone with a reduced 40 km/h speed limit could be implemented under the current council approved policy. The Community Safety Zone, and reduced speed limit are to be implemented on all roadways which have direct access to an elementary school. The designated zone on the roadway shall be 250 meters either side of the school property.

12. An information letter was prepared and mailed to 164 property owners along Churchland Drive to advise of a Community Safety Zone and reduced 40 km/h speed limit will be implemented along Churchland Drive. Staff received one (1) response which was in support of the Community Safety Zone and reduced 40 km/h.

- 13. The resident did express concern regarding parking congestion during drop off and pick up times at St. Bernadette Elementary School. Staff have reviewed this and have noted vehicles do park along Churchland Drive during drop off and pick up times. Staff will continue to monitor the situation.

SANDRINGHAM DRIVE

- 16. Staff reviewed the pedestrian walkway along Sandringham Drive and determined the current Community Safety Zone and reduced 40 km/h speed limit could be extended in accordance with the current council approved policy. The Community Safety Zone, and reduced speed limit are to be implemented on all roadways which have direct access to an elementary school. The designated zone on the roadway shall be 250 meters either side of the school property.
- 17. An information letter was prepared and mailed to property owners along Sandringham Drive to advise of a Community Safety Zone and reduced 40 km/h speed limit will be extended to Proclamation Drive. Staff did not receive any responses regarding implementing the Community Safety Zone and reduced 40 km/h.
- 18. Staff recommend that Community Safety Zone (CSZ) By-law 2003-160, Schedule "A", be amended by deleting the following:

ALTERNATIVES

24. There are two (2) alternatives available for consideration by General Committee:

Alternative 1 General Committee could decide not to implement a Community Safety Zone and reduced 40 km/h along Churchland Drive.

This alternative is not recommended as there is a pedestrian walkway which provides a direct connection from Churchland Drive to St. Bernadette Elementary School and based on the current council adopted policy all roadways which provide a direct connection to an elementary school shall have a Community Safety Zone and reduced 40km/h speed limit.

Alternative 2

General Committee could decide to maintain the current Community Safety Zone and reduced 40 km/h limits of Sandringham Drive between Big Bay Point Road and a point 135 meters north of Consort Drive.

This alternative is not recommended as the current Community Safety Zone and 40 km/h limits do not include the pedestrian walkway access from Sandringham Drive and based on the current council adopted policy all roadways which provide a direct connection to an elementary school shall have a Community Safety Zone and reduced 40km/h speed limit.

FINANCIAL


25. The cost of implementing the proposed Community Safety Zone and reduced 40km/h speed limit zones along Churchland Drive and Sandringham Drive is approximately \$1,000, which can be accommodated in the 2019 Business Plan.


LINKAGE TO 2018-2022 STRATEGIC PLAN
