


I. Investment Performance



Doing more with less: Increasing return translated to higher income against declining capital

Impact of the investment program:

Moving from 100% low return cash portfolio to a higher yielding diversified portfolio



II. Prudent Investor Standard

- Investment decisions based on impact on total portfolio
- Broader asset classes: fixed income, equities, alternative asset classes...
- Better risk adjusted performance through allocation to higher yielding assets
- Lower risk through diversification




...Fixed Income and Equities Move In Opposite Directions: Higher Risk Adjusted Returns Through Diversification







Framework Under Prudent Investment Standard

- Council sets goals and objectives through Investment Policy Statement.
 - Appoints an Investment Board to control and manage investments
 - Investment Board creates Investment Plan to achieve Council's goals and objectives.
 - Appoints agents to execute the Investment Plan – investment managers (internal and/or external)



...Investment Board

- MEMBERSHIP
 - Independent members (3); plus
 - Treasurer (limited to 25% of board membership)
- TYPES
 - City Board—solely appointed by Council
 - Joint Board appointed in accord with others



usually 3rd Party Asset Managers
