RECOMMENDED MOTION

1. That the following names be added to the City's Municipal Names Registry:
 - a) Pidutti;
 - b) Zaba; and
 - c) Terry Fox.

PURPOSE & BACKGROUND

Report Overview

2. The purpose of this report is to recommend a list of names to be added to the Municipal Names Registry to be used to facilitate the naming of streets, in future developments within the City.
3. The Municipal Naming Policy last updated in January 2016 establishes the processes and criteria for naming, renaming, and dedicating Municipal Assets such as streets, parks, and facilities as well as the major elements of such municipal assets including the methods by which the public may provide suggestions and comments.
4. The Municipal Names Registry is a central repository of all approved names for streets, parks, and facilities including names submitted that qualify, but may not be chosen by the Municipal Naming Working Group for a particular asset.
5. City Council recommended by motion 13-G-166: "That the name EMIL PIDUTTI, in memory of Emil Pidutti and in recognition of his extensive contribution to the development of Barrie and his charitable contributions within the community, staff in the Planning Services Department add Emil Pidutti to the approved street name list, subject to obtaining concurrence from the Emergency Service Partners, and Council be notified via memorandum once a suitable street within an employment area in the City has been identified."

6. City Council recommended by motion 13- G-213: "That in memory of Al Zaba and in recognition of his significant contributions to the community, that staff in the Planning Services Department add Al Zaba to the approved street name list, subject to obtaining concurrence from the Emergency Service Partners and Council be notified via memorandum once a suitable street within the annexed lands has been identified."
7. City Council recommended by motion 1-G-230: "That in memory of Terry Fox and in recognition of his Marathon of Hope to raise funds for cancer research and ongoing fundraising in his name, staff in the Planning Services Department add Terry Fox to the approved street name list subject to obtaining concurrence from the Emergency Service Partners and Council be notified via memorandum once a suitable arterial or major collector road/street within the annexed lands has been identified.'

ANALYSIS

8. The proposed Street Names met the Criteria of the Naming Principles set out in the Municipal Naming Policy.
9. The proposed Street Names were circulated to appropriate City departments and external stakeholders, including Emergency Services for commenting.
10. There is no conflict with existing street names at either the local or County levels; however Emergency Services recommended as best practice that only the last name be used when naming a street.
11. Appendix "A" to Staff Report PLN010-18 identifies the new collector roadways within the Salem and Hewitt's Secondary Plan areas.
12. Street Name "**Terry Fox Drive**" has been designated for a new collector roadway in the Hewitt's Secondary Plan Area; this collector is proposed to be extended between Lockhart Rd and Big Bay Point as shown in Appendix "A" of Staff Report PLN018-10 attached to this report.
13. Street Name "**Zaba Road**" has been designated for a new collector roadway in the Hewitt's Secondary Plan Area; this collector is proposed to be extended in east-west direction from 20 Sideroad to Terry Fox Drive as shown in Appendix "A" of Staff Report PLN018-10 attached to this report.
14. Street Name "**Emil Pidutti**" is ready to be used at any time.
